# What are we?

- An **Executive Agency** established/supervised by the Commission
- Entrusted with the management of parts of **EU programmes** and related **Union budget**
- Own **legal personality** and represented by a **Director** appointed by the Commission
- Supervised by a **Steering Committee**, and managed by the Director aided by a **Management Team**

# Partnership with the Commission

## European Commission

### Defines the policy

- Defines strategy, objectives and priority areas/work programmes
- Selects actions for co-financing
- Makes programme decisions
- Evaluates the programme and the Agency's performance



## INEA (Executive Agency)

### Turns policy into action

- Manages the project lifecycle:
  - Organises Calls for Proposals and external evaluations
  - Monitors technical/financial implementation of projects
  - Manages communication actions (Info Days, website, publications)
- Provides feedback to policy making

# INEA's programmes and budget

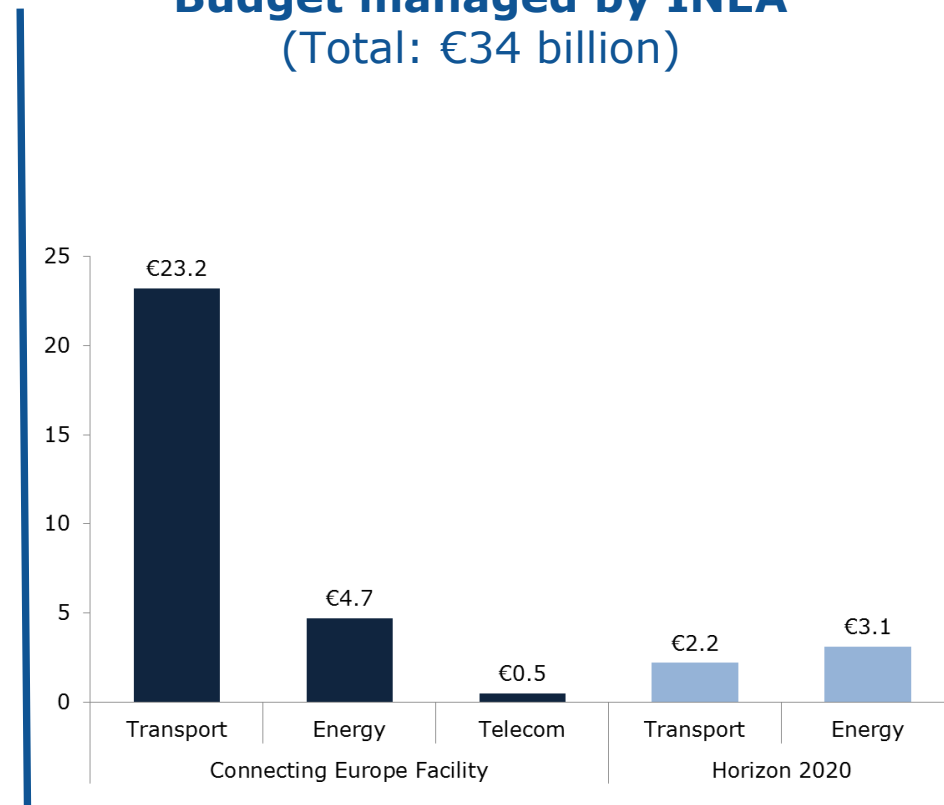
MFF 2014–2020

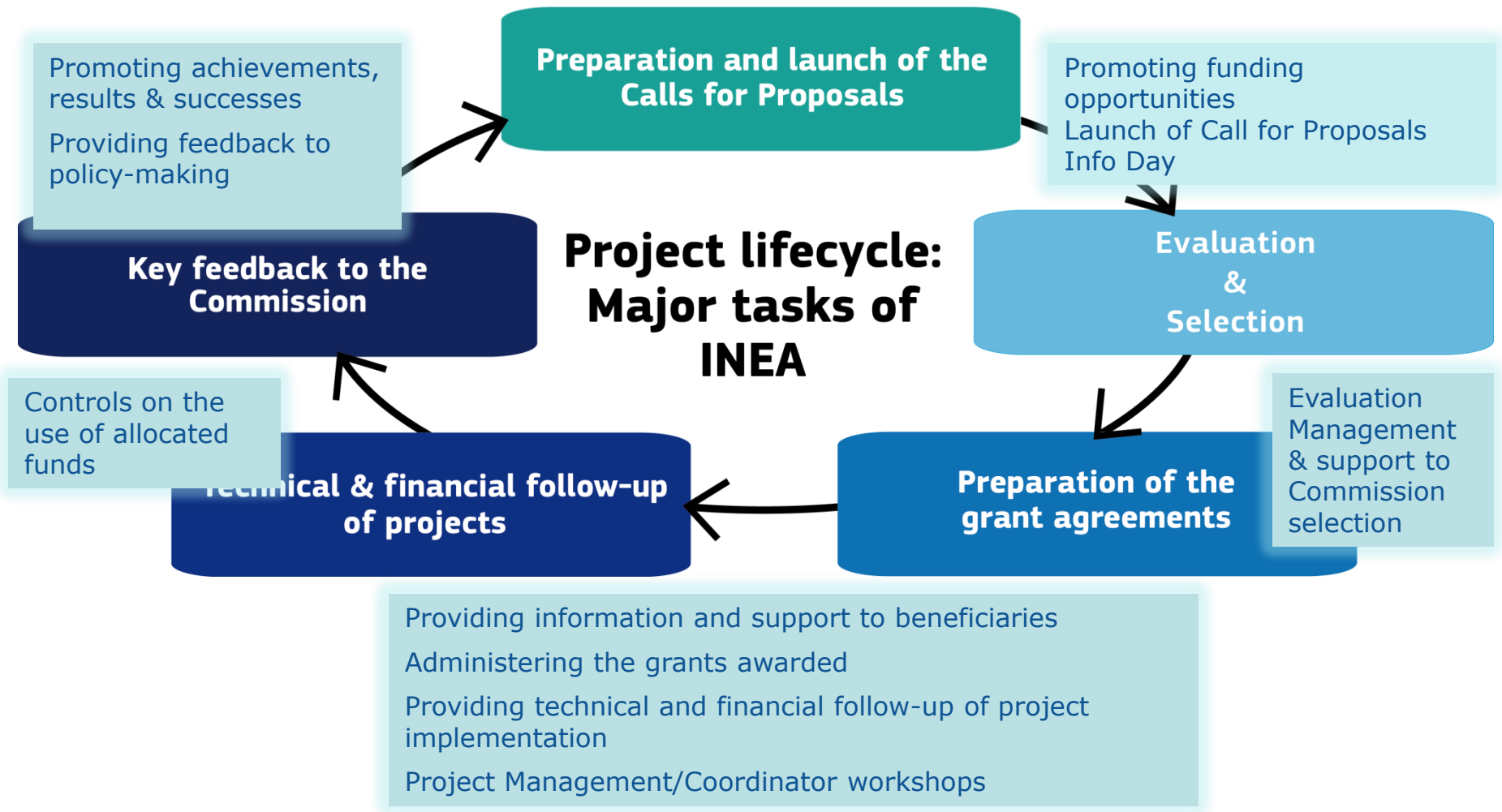


Legacy Programmes (2007–2013)

# eDelivery implementation by INEA

- *CEF eDelivery building block supports public administrations to exchange electronic data and documents with other public administrations, businesses and citizens, in an interoperable, secure, reliable and trusted way.*
- *CEF funding offered for:*
  - **deployment of eDelivery AS4 Access Point (AP) + up to one year operation**
  - **deployment of Service Metadata Publisher (SMP) + up to one year operation**
  - **or upgrade of existing exchange data solutions duly complying with the CEF eDelivery standards.**

# eDelivery implementation by INEA

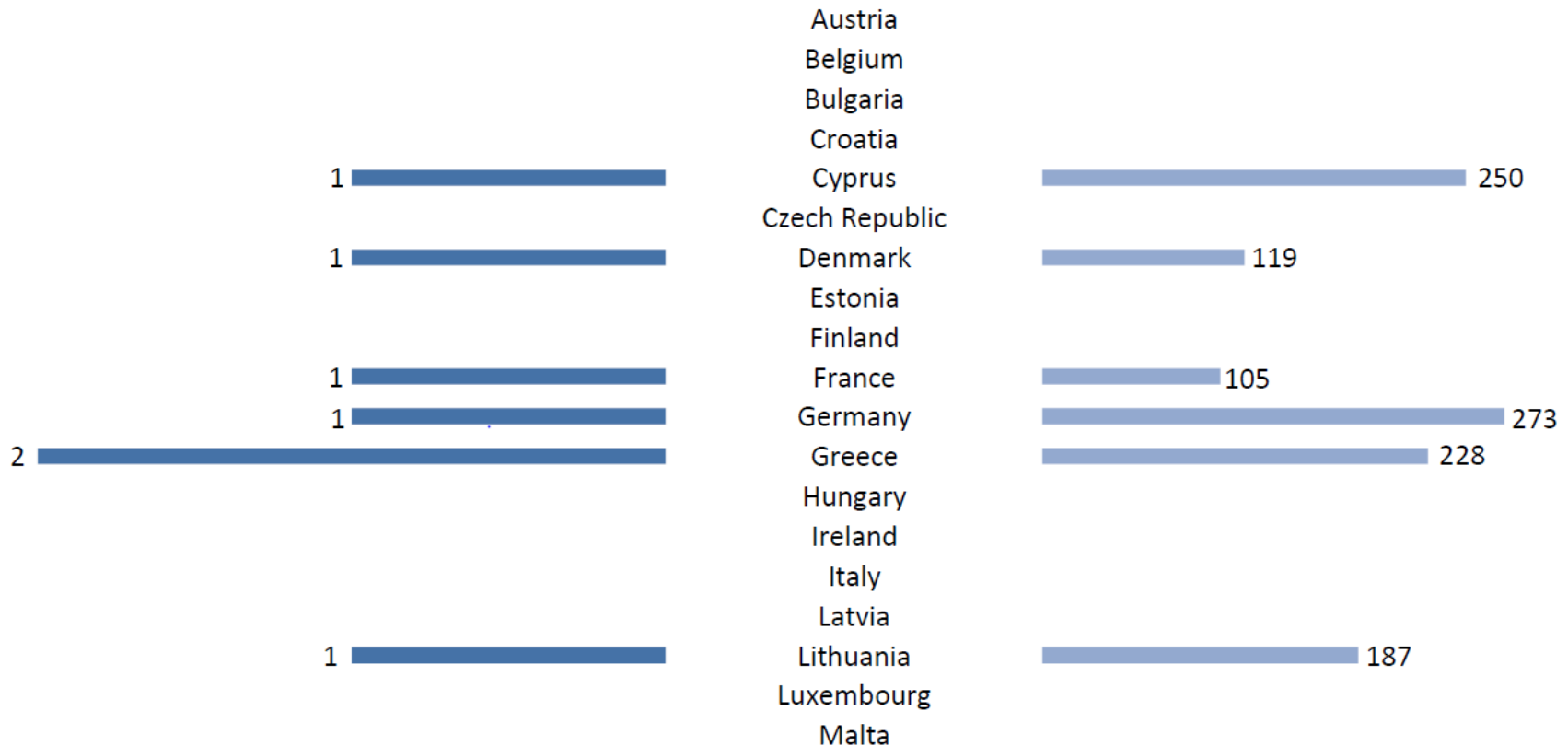
- *First call in 2015 and then each year, APs supported as of 2015, SMP as of 2016*
- *9 agreements signed by end of 2016 with a total of €2.6 million of CEF funding*
- *for 11 Member States and two EEA Countries, corresponding to a total cost of €3.6 million*
- *Support for deployment of 21 access points under eDelivery*

## eDelivery implementation by INEA

- *Under the 2017-2 call 3 proposals selected accepted for CEF funding for a total amount of € 632,976 – Grant Agreements under preparation*
- *A further 10 AS4 Access Points and SMPs within PEPPOL network will be supported*
- *Newly supported countries: Belgium, Ireland, Sweden, Italy*

## Reuse of eDelivery

*eDelivery is also deployed as part of several Grants awarded following calls for proposals and under preparation for a number of other DSIs including:*

- *eInvoicing,*
- *eJustice*
- *Business register interconnection systems (BRIS)*
- *Automated Translation*
- *eProcurement*

*In total: 55 APs supported*

# eDelivery 2018-2 call: Objectives

- **(a) Deploy AS4 Access Point(s) (AP) + Operation (up to 1 year)**
  - When applicable, pass the connectivity tests
- **(b) Deploy Service Metadata Publisher(s) (SMP) + Operation (up to 1 year)**
  - When applicable, pass the connectivity tests
- **(c) Upgrade data exchange solutions** (such as Commercial Off-the-Shelf - COTS, Open-Source Software –OSS, and other) to support, and duly comply with, the CEF eDelivery standards.
  - Pass the conformance tests
- In **a production environment**, i.e. an operational environment where users can perform actual business transactions

No longer funding available for deploying an AS2 Access Point (but transition to AS4 is supported)

## eDelivery 2018-2: Eligibility of applicants

- Consortium composition
  - Submitted by consortia consisting of **at least two entities from one or more Member State(s)**.
  - Public and/or private entities
- Member states, Norway, Iceland
- Third countries including acceding and candidate countries – eligible to participate, where necessary to achieve the objectives of project and where duly motivated

# eDelivery 2018-2 call

- Budget: indicative 0.5 M euros
- Co-funding rate: 75%
- Indicative duration of the actions: 18 months
- Pre-financing: 50%
- No interim payment
- Final payment of the balance after accepting the supporting documentation (final report, financial statements, etc.)

## eDelivery Call 2018-2 call timeline

<b>Deadline for the submission of proposals</b>	<b>18 September 2018</b> (17:00 Brussels time)
Evaluation of proposals	October – December 2018
Consultation of CEF Coordination Committee Information of European Parliament	January 2019
Adoption of Selection Decision	January 2019
Preparation and Signature of individual Grant Agreements	As of January 2019 until Mid- June 2019
