# STARTUP EUROPE

Startup Europe is an initiative of the European Commission designed to connect startups, investors, accelerators, entrepreneurs, corporate networks, universities and the media through an array of [networks](#) [3]. Furthermore, it intends to connect local [startup ecosystems](#) [4] around Europe and enhance their capacity to invest in other markets such as [Silicon Valley](#) [5] or [India](#) [6].

Not less important, it celebrates the European entrepreneurs' success, making it visible and rewarding (e.g. [Startup Europe Awards](#) [7]).

## Startup Scaleup initiative

The [Startup Scaleup initiative](#) [8] is based on a communication from the European Commission ([Europe's next leaders: the Startup and Scaleup Initiative](#) [8]), released in 2016, which two main objectives are:

- to remove barriers to scaling up in the single market with [ecosystem building projects](#) [4];
- to develop [networking opportunities](#) [3], enhancing the startup ecosystem - by connecting clusters, people, and local ecosystems across Europe.

Additionally, it responds to the demands of the technology founders addressed within the [Startup Manifesto](#) [9] and [Scaleup Manifesto](#) [10].

The initiative also includes activities to help startups finding international outreach. Through the [One Stop Shop](#) [11], startups and [ecosystem builders](#) [4] have easy access to all the funding services and other support offered at EU level.

Along the [Startup Scaleup initiative](#) [8], the Commission further explores measures to:

- facilitate uptake of new technologies;
- create better opportunities for access to [finance](#) [12] and [skills](#) [13];
- maximise the effectiveness of Europe's [ecosystems](#) [4].

Startup Europe and the European Commission cooperate to increase the impact of its initiatives and accelerate the growth of the European startup scene.
