Revision of the PSI Directive

The review of the Directive is one of the key actions of the ["Digital Agenda for Europe"](#) [1].

In December 2011, the Commission presented a [proposal to revise the Directive](#) [2].

The proposal for a revision of the Directive proposed to further open up the market for services based on public-sector information, by:

- including new bodies in the scope of application of the Directive such as libraries (including university libraries), museums and archives;
- limiting the fees that can be charged by the public authorities at the marginal costs as a rule;
- introducing independent oversight over re-use rules in the Member States;
- making machine-readable formats for information held by public authorities the norm.

Background

In preparation for the proposed revision of the 2003 Directive, the Commission in 2009 presented a first [review](#) [6] of the way in which PSI rules were being applied. The review confirmed that PSI re-use has been on the rise but also that EU Member States must remove remaining barriers to re-use in order to fully realise the potential of PSI for the EU economy.
