## **European Regulators Group for Postal Services (ERGP) 9<sup>th</sup> Plenary Meeting** Brussels, 3 December 2015

The European Regulators Group for Postal Services (ERGP) met in the second plenary session of 2015 in Brussels, under the chairmanship of Feliksas DOBROVOLSKIS, Director General of the Lithuanian Communications Regulatory Authority (RRT).

During this plenary meeting, the ERGP members adopted a series of documents, notably the *"ERGP Report on the quality of service, consumer protection and complaint handling 2014 - an analysis of trends"* [ERGP PL (15) 26], the *"ERGP Report on core indicators for monitoring the European postal market"* [ERGP PL (15) 27], the *"ERGP report on legal regimes applicable to European domestic or cross-border e-commerce parcels delivery and, particularly, any provisions that could be in conflict with each other"* [ERGP PL (15) 28] and the *"ERGP Report on the possible impact of Article 12 application after ECJ C-340/13"* [ERGP PL (15) 29]. Furthermore, two *Flash Reports*, namely on the *Report on the quality of service, consumer protection and complaint handling 2014* [ERGP PL (15) 33] and on the *Report on core indicators for monitoring the European postal market* [ERGP PL (15) 34] were adopted. A joint ERGP-BEREC ad-hoc working group on cross-border parcels had been set up with the aim of analysing whether regulatory insights from the electronic communications sector can be transferred to the cross-border parcels sector. The joint ERGP-BEREC Opinion on "Price transparency and regulatory oversight of cross-border parcels delivery, taking into account possible regulatory insights from the electronic communications sector" [ERGP PL (15) 32] was adopted by the ERGP plenary; it has been adopted by BEREC on 10 December 2015 [BoR (15) 214]. The ERGP also approved for public consultation its Draft Work Programme for 2016 which includes work on assessing the efficiency of postal operators and the changing needs of postal users and also provides for monitoring of the evolution of the core indicators of the European postal market, of the quality of service and the development of end-to-end competition in the postal sector. Also, in the context of the European Commission roadmap for completing the single market for parcel delivery and the DSM Strategy, the ERGP intends to continue advising the Commission concerning cross-border e-commerce parcels delivery. The *"ERGP Work Programme 2016 - ERGP PL (15) 35"* will be subject to a public consultation that runs from 9 December 2015 until 18 January

2016.

The ERGP plenary elected with unanimity Professor Angelo Marcello CARDANI, President of the Italian Autorità per le garanzie nelle comunicazioni (AGCOM) to become the Chairman of the ERGP for 2017. Together with Feliksas DOBROVOLSKIS he will serve as one of the two vice-chairs of the ERGP in 2016. On 1 January 2016 Mr Veselin BOZHKOV, Chairman of the Bulgarian Communications Regulation Commission (CRC) will take over as the Chair of ERGP.
