Basic terms - terminology

Law 336/2015 Z.z. support the least developed districts and the amendment of certain laws (employment law) differentiates between:

- Social Enterprise Labor Integration (SPPI)
- Social Economy Enterprise (SSE)

Specific case - **Social Municipal Enterprise** - SOP (can be SPPI respectively SSE), where founder / founder SOP is a municipality respectively group of municipalities within their one functional area, or on the micro regions level.

Basic sources

Support for social economy entities in SR is supported through:

- **support programs** (ESI + and other financial instruments) at national level and within the EU,
- financial and non-financial incentives for SSE startups,
- **creation of a favorable regulatory environment** (new legislation on state aid, public procurement ...) as an ecosystem, framework
- **support of various civic and community initiatives** (LEADER approach...).

Q1: Do you think that this possibility is well known in your country, both by contracting authorities and by social economy enterprises themselves?

- so called "reserved contracts" in Slovak application practice are used mainly in the support of disabled - sheltered workrooms and sheltered workplaces,
- insufficient use is reserved contracts in the promotion of social economy entities notable exception - the application of social aspects in public procurement,
- partly in new operational programs the operational programmes, for public and private sector applicants.

Q2: What are the main barriers in the use of reserved contracts in your country?

- there is no legislation 'reserved contracts "for the social economy subjects, the Employment Law indeed defines such entities (SPPI and SSE), but the law only regulates the IN reserved contracts to sheltered workshops and sheltered workplaces,
- **limited experience and readiness / skills** of actors, for example in the separation of orders, setting criteria for the application of social aspects in public procurements,
- **insufficient public pressure** / public opinion on the use of social aspects in public procurements.

Q3: What are your views and your experience about this?

Lowest price

Easier organization of the competition, cheap solution, saving initial costs

Firmly set quality parameters. The lower price could mean lower quality The most economically advantageous tender


Managing Quality Expectations

Approach 2: Social aspects in public procurement

- inclusion of social aspects in the subject of the contract,
- sanctions for infringements of the social rights,
- a commitment to the achievement of social standards,
- compliance with the terms and conditions,

- to experience the difficult process of public procurement, the subject of the contract and the follow-up legislation,
- specificity in selection of appropriate criteria and weighting,
- time consuming preparation and impact on the costs of procurement,
- emphasis on teamwork and professionalism.
