Background to RIA in Ireland Department of the Taolseach

- 1. 2001: OECD Peer Review
- Draft RIA Model developed
- 3. 2002: Introduction of integrated Impact Assessment by European Commission
- 4. 2004: White Paper *Regulating Better* set out broader policy agenda and committed to piloting RIA





RIA model

Two-phase approach:

Screening RIA

 Full RIA: only conducted where Screening RIA suggests significant impacts (six criteria identified) or costs







Outcome of Pilot Process

Demonstrated many of the benefits of RIA:

- A more structured and explicit focus on the objectives behind regulations-what problem is being addressed
- Identification and analysis of alternative options for achieving policy goals
- More analysis and quantification of costs associated with regulations-link to administrative burdens issue





Outcome of Pilot Process cont'd Roin an

- Encouraged a more structured and explicit examination of expected benefits
- Highlighted importance of consultation with stakeholders
- Encouraged earlier focus on enforcement and compliance issues-who will enforce the regulations, what are the compliance targets?

Outcome of Pilot Process cont'd Roin an Taolsigh Department of the Taolsigach

 Introduced idea of performance indicators for regulations-how will we know the regulations are working well?

Can help address cross-cutting issues

 Showed that RIA could help inform Ireland's negotiating position and transposition of EU Directives







- Policy Review Groups
- Primary Legislation: Before seeking Government decision to draft legislation
- Significant Statutory Instruments
- EU Legislation







EU Legislation

- National RIA to be carried out once Draft Directives have been published by Commission
- Use the Commission Impact Assessment as a starting point, but focus on specific national impacts and feed into negotiations
- National RIA to take account of transposition options
- Information note for Parliament's European Scrutiny Committee takes account of RIA Model







- RIA must be applied at an early stage in the regulatory cycle - before Government decides to regulate
- Costs and benefits should be specific and relevant







Launch of RIA in Ireland

 Report to Government June 2005 on RIA Model

Launched July 2005 by Taoiseach

 Launch of Consultation Guidelines simultaneously







Responsibility for RIA

- RIAs to be conducted by Departmental officials overseeing policy area where regulation proposed
- Oversight role for the Department of the Taoiseach, Department of Finance
- Departments to ensure impacts within their policy areas reflected in RIAs





RIA Supports

- RIA Guidelines published October 2005
- RIA Training Module running each month
- Better Regulation Unit, D/Taoiseach available to guide, advise and support Depts
- Economic Consultant available to Depts
- Review of operation of RIA after 2 years





Critical success factors

- Convincing Senior Management of benefits
- Starting the process early
- Awareness-raising and training of Officials
- Availability of "just in time" support, advice and expertise
- Learning from doing-RIA very much an iterative process







Future Challenges

- Cultural Change embedding RIA in the system
- Avoid 'overburdening' the model
- Demonstrate added value of RIA
 Does it deliever better decisions/results?
- Focus on outcomes monitoring and review
