# The EU Raw Materials Knowledge Base in support of the EU Raw Materials Policy

Knowledge is essential for ensuring a sustainable and secure global supply of raw materials, both primary and secondary, to the EU's economy and society. Proper knowledge management promotes activities of the raw material sector, regarding not only exploration, extraction, processing/refining and recycling, but also investments, innovation, trade, development, skills and education. Knowledge is also key for policy support, informed debate and decision-making.

The EU Raw Materials Knowledge Base (EU RMKB) and, at its core, the European Commission's Raw Materials Information System (EC RMIS), support the European Commission, Member States, business and the research community. The RMIS, as it was designed by the Commission's JRC, provides the vital interface between policy and the EU RMKB. In particular, this facilitates harmonised availability of key data and analyses, highlights priority needs, as well as contributes to coordinated dissemination. Data and analyses are provided by a variety of sources. Hence, the RMIS facilitates - among others - analyses of raw materials' criticality, development of the Raw Materials Scoreboard, assessment of progress towards a more Circular Economy, availability of background information for trade, as well as greening the single market and improving social conditions associated with supply chains.

In the context of the EU RMKB and the EC RMIS, this workshop will focus on:

- The importance to EU raw materials' policy of knowledge provision by different stakeholders, including H2020 projects, and of knowledge management;
- Existing data and statistics at international, European and national levels, with emphasis on key needs and gaps;
- Policy-making and decision-making in the raw materials sector;
- The RMIS' scope, functionalities, and opportunities for interaction;
- The contributions of a few example European-funded projects.
