



European Union Short-Term Tourism Trends Volume 1• 2017- 5

Overview

This release of the *European Union Short-Term Tourism Trends* presents inbound tourism trends in the European Union (EU-28) based on preliminary 2017 year-to-date results of international arrivals and receipts (with the most timely destinations having reported up to the first 9 months of 2017 by the end of October). Furthermore, it provides a glance of outbound tourism trends based on international tourism expenditure data for major source markets.

According to available data, half of the **28 countries of the European Union** recorded double-digit growth in arrivals. It is estimated that, overall, EU-28 destinations recorded a strong 8% increase in **international tourist arrivals** through August 2017, compared to the same period last year. Within the EU-28, growth was strongest in EU-28 destinations in Southern and Mediterranean Europe (+10%).

Out of the world's top 10 tourism earners, 5 countries belong to the EU-28 countries. Spain recorded the highest growth (+12%) in **international tourism receipts**, followed by France (+10%) and the United Kingdom (+9%). Italy (+7%) and Germany (+4%) also reported good results.

In terms of **international tourism expenditure**, 4 of the world's top source markets belong to the EU-28. Tourism spending from the United Kingdom grew 5%. Germany (the world's third largest market) and Italy both posted 4% growth. Meanwhile, spending from France grew 1%.

International Tourist Arrivals year-to-date 2017

With most countries having reported data on inbound tourism for at least three and up to nine months of 2017, the following section presents preliminary results for international tourist arrivals to EU-28 and Extra-EU destinations in 2017.

Strong growth continues during the Northern Hemisphere summer peak season

Destinations worldwide received an estimated 901 million international tourists (overnight visitors) in the first eight months of 2017, some 56 million more than in the same period of 2016. This corresponds to a strong 7% growth compared to the same period last year, well above the increase of 4% to 5% in previous years.

The first eight months of the year typically account for 68% of total international arrivals of the year. The Northern Hemisphere summer peak season months of July and August are traditionally the busiest. In 2017, they accounted for around 150 million visitors each, for the first time ever.

Results are underpinned by the sustained growth in many destinations combined with the recovery of those suffering from security challenges in recent years. By UNWTO region, growth was strongest in Africa (+9%) and Europe (+8%), followed by Asia and the Pacific (+6%), the Middle East (+5%) and the Americas (+3%).

Southern and Mediterranean Europe in the lead

Europe as a whole (both EU-28 and Extra-EU destinations), the world's most visited region, recorded a robust 8% increase in international arrivals in the first eight months of 2017, compared to the same period last year. This is a remarkable growth pace for such a mature region with a large base volume of tourists and in a period including the Northern Hemisphere summer peak season. Results reflect a recovery in destinations that suffered from security incidents in 2016, such as Turkey, France and Belgium, combined with strong performance of destinations in Southern and Mediterranean Europe (+12%). Western Europe (+7%) and Northern Europe (+6%) also recorded solid results, while results in Central and Eastern Europe (+4%) were rather mixed.

Extraordinary pace of growth in EU-28

Out of the **28 European Union destinations**, 14 recorded double-digit growth in arrivals during 2017 year-to-date, leading to an overall robust 8% increase (+5% in 2016). Demand was strong from virtually all source markets, both intra- and interregional. The rebound in tourism demand from the Russian Federation also benefitted many EU-28 destinations. Based on the reported data it is estimated that EU-28 countries welcomed 378 million international tourist arrivals (overnight visitors) in the first eight months of the year, 27 million more than the 351 million in the same period of 2016.

- Most of the eight **European Union destinations in Southern and Mediterranean Europe** (+10%) posted strong results. Portugal (+12%) and this group's top destination Spain (+10%) continue to boast double-digit growth following already strong results in 2016. The terrorist attack in Barcelona last August has only had a very limited, short-lived and localised impact, not affecting overall tourist arrivals to Spain. Greece also posted 10% growth, while Italy, the second largest destination in this group, reported 7% growth in arrivals. Balkan destinations Slovenia (+18%) and Croatia (+15%) also reported double digit growth, as did island destinations Malta (+17%) and Cyprus (+15%).

- Arrivals to the group of six **European Union destinations in Western Europe** (+7%) have strongly rebounded in the first eight months 2017 following last year's flat results (0%). Growth has been fuelled by the recovery of Belgium (+12%) as well as the world's top destination France (+8%) after last year's drop in arrivals in the aftermath of several terrorist attacks. The Netherlands posted a remarkable 13% increase in arrivals following sound results in 2016. Arrivals to Germany (+6%) and Austria (+5%) were also strong.
- The nine **European Union destinations in Central and Eastern Europe** recorded a 6% growth in arrivals in the first eight months of 2017. Growth was strongest in the Czech Republic (+13%), followed by Latvia and Romania (both +12%) and Bulgaria (+10%). Slovakia (+9%), Lithuania (+6%), Poland and Estonia (both +5%) also recorded sound results. Meanwhile, Hungary posted a 2% decrease in arrivals.
- International arrivals to the five **EU-28 destinations in Northern Europe** also grew 6% through August. Finland (+14%) recorded double-digit growth in arrivals. The United Kingdom reported an 8% increase, consolidating the good results of last year despite terrorist attacks in London and Manchester. Sweden and Denmark both reported a 4% increase and Ireland 3%.

Extra-EU destinations report solid growth in arrivals after last year's decline

International arrivals to the **26 destinations outside the European Union (Extra-EU)** grew 9% in the first eight months of 2017 after last year's 8% decline, with most destinations reporting robust results. The recovery of Turkey (+31%) following last year's decline has fuelled growth.

- The nine **Extra-EU destinations in Southern and Mediterranean Europe** recorded a notable 24% recovery in arrivals, following a 20% decrease in 2016. Growth has been driven by the recovery of this group's largest destination Turkey (31%) after last year's 29% decline and the upsurge in demand from the Russian Federation. Israel (+22%) and Balkan destinations FYR Macedonia (+23%), Bosnia & Herzegovina (+19%), Montenegro and Serbia (both +18%) all reported double-digit growth.
- Arrivals in the five **Extra-EU destinations in Northern and Western Europe** increased 5% through August 2017. Switzerland (+7%), the largest destination in this group, reported sound results as did smaller destination Iceland (+16%). Arrivals to Norway (+2%) were comparatively modest.
- Arrivals in the 12 **Extra-EU destinations in Central and Eastern Europe** declined slightly (-1%) during the first eight months of 2017. Double-digit growth in several countries, such as Armenia (+24%), Kazakhstan (+21%), Georgia (+19%) and Moldova (+18%) was offset by an 8% decrease in arrivals to the Russian Federation (-9% in 2016), the largest destination in this group. Arrivals data for Ukraine is still pending.

Note: All results presented in this issue are based on preliminary data as reported by the various destinations around the world and UNWTO estimates of still missing data. More complete information on 2017 will be included in the next issue of the *European Union Short-Term Tourism Trends*.

International Tourism Receipts year-to-date 2017

Growth in earnings matches growth in arrivals

Preliminary data on international tourism receipts have been reported by 135 countries and territories so far for the first three to nine months of 2017. Of the reporting destinations, a total of 110 (or 81%) posted growth in earnings compared to the same period last year (in local currencies at current prices), of which 59 (44%) in double digits, while 25 (19%) posted declines. To a large extent, this indicates that earnings mostly followed the solid trend seen in arrivals. The median increase on international tourism receipts was 8%.

Results reported by the top 10 tourism earners of **international tourism receipts** were fairly strong. Among them, 5 destinations belong to the EU-28: Spain recorded the highest growth year-to-date (+12%), following 7% growth in the full year 2016. France posted an increase of 10%, rebounding from last year's decline in receipts. The United Kingdom reported 9% growth in receipts. Italy reported 7% growth in tourism earnings, while Germany posted 4% growth.

Of the remaining five destinations in the top 10, three reported growth in tourism receipts while two reported declines. Australia posted a 12% increase. Thailand recorded 8% growth, after an increase of 15% in 2016. The United States reported 3% growth in tourism earnings. Meanwhile, receipts decreased 1% in Hong Kong (China) and 8% in China.

Beyond the top 10, a number of EU-28 and Extra-EU destinations also performed strongly in the first months of 2017. The Russian Federation reported a strong 21% increase, rebounding after three years of declines. Portugal reported a 19% increase in tourism earnings, following solid results in 2016. Israel, the Netherlands and Croatia all posted a 12% increase. Poland and Turkey (both +11%) also recorded double-digit growth in tourism earnings. Other top performers this period were Sweden and Greece (+both 9%), as well as the Czech Republic (+8%).

International Tourism Expenditure year-to-date 2017

Major source markets report robust growth in tourism spending

Preliminary year-to-date results on international tourism expenditure reflect increasing demand for outbound travel from the world's major source markets. Spending data is consistent with the robust 7% increase in international arrivals this year.

So far, 48 out of the top 50 outbound markets have reported preliminary data on international tourism expenditure for the first three to nine months of 2017, of which 45 have reported for at least the first six months. Out of 48 reporting countries, 39 (81%) recorded an increase in tourism spending (in local currencies at current prices), 13 of which in double digits (27%), while 9 (19%) posted declines. The median increase was 5%.

In terms of **international tourism expenditure**, 4 of the world's top 10 source markets belong to the EU-28. The United Kingdom reported 5% growth in spending. Germany (the world's third largest market) and Italy both posted 4% growth. Meanwhile, spending from France grew 1%.

The remaining six destinations in the top 10 also reported growth in tourism spending. China, the world's top source market, reported a 19% increase in tourism spending in the first half of 2017, compared to the same period in 2016, reflecting Chinese travelers' continued strong demand for international travel. The United States (the world's 2nd largest market) recorded an 8% increase. The Republic of Korea posted 12% growth in tourism spending, the second highest after China, followed by Canada, which reported a 7% increase in tourism spending, rebounding after flat growth in 2016. Hong Kong (China) recorded 5% growth. Australia posted a 3% increase in expenditure.

Beyond the top 10, a number of source markets showed strong growth in spending this period. Within the EU-28, Spain and Portugal (both +13%) reported double-digit growth in international tourism spending, while the Czech Republic (+10%) and Ireland (+7%) also reported strong results.

Outside the EU-28, growth in spending rebounded remarkably in Brazil (+35%) and in the Russian Federation (+27%) after some years of declines. The recovery of the Russian federation is expected to fuel arrivals in Turkey and Egypt, among other major destinations for Russian travelers. Other important source markets that showed robust demand for outbound travel this period were Israel (+12%), Ukraine, Colombia and Thailand (all +8%), as well as Taiwan (pr. of China) (+7%).
