

Commitments, 2022 - 2025

- **1. Best Practice Exchange Group** to engage its members and partners to gather and evaluate **"good practices"** in Accessible Tourism
- 2. Best Practice Exchange Group of NTOs and DMOs on policies and plans for implementation of support measures for Accessible Tourism in all EU Member States.
- **3.** Best Practice Exchange Group on Skills development and Inclusion in the workplace, focusing on employment of persons with disabilities in the tourism sector.



ENAT - Together for EU Tourism (T4T)

Proposed measurable targets, 2022 - 2025

- 1. 100% increase in the number of published Projects and Good Practices in the ENAT Accessible Tourism database from 2022 to 2025, in association with ZERO PROJECT. See: <u>https://www.accessibletourism.org/projects</u>
- 2. Organisation of minimum 6 networking/training events per year for the tourism sector
- 3. Annual Report on "Accessible Tourism actions in support of the Transition Pathway for Tourism" (2022 to 2025).
- 4. Re-launch of the <u>www.pantou.org</u> website with enhanced features and user community. Target date to be set within 2023.
- 5. Establishment of 3 Best Practice Exchange Groups in cooperation with ENAT members and partners by Spring 2023.



Networking for T4T success

NGOs can play a positive role in T4T

- by bringing together different actors and stakeholders around themes of common interest:

- Working for mutual benefit
- Seeking consensus based on the experience and aims of all parties
- Targeting agreed goals
- Creating common tools and methods
- Engaging with policy makers
- Mobilising EU funds and private sector investments to reach the goals
