The National Authority for Management and Regulation in Communications of Romania elaborated the *Sector Market Surveillance Programme - 2014*, in accordance with the provisions of Article 18.5 of Regulation (EC) No 765/2008.

The National Authority for Management and Regulation in Communications (ANCOM), as market surveillance authority according to the provisions of Government Decision No 88/2003 on radio and telecommunications terminal equipment and the mutual recognition of their conformity, republished, transposing Directive 1999/5/EC, as well as of the Government Decision No 982/2007 on electromagnetic compatibility, transposing Directive 2004/108/EC, has set up its own sector programme for the field covered by the two directives.
