ANNEX 1 - METHODOLOGICAL NOTES TO PART I

Conventions

- 1. Billion means 1000 million.
- 2. All monetary values are expressed in current Euro, if not otherwise specified
- 3. Global figures were converted from US\$ to Euro using current exchange rates from the US Federal Reserve.
- 4. Average yearly growth rates are calculated as a geometrical mean

Main variables used in the report

1. Furniture trade data (import, export), trade balance

Sources

Furniture trade data were processed by CSIL mainly on the basis of UN (UN Comtrade database, DESA/UNSD) and Eurostat data (Comext database). Other sources include: US Census Bureau, Industry Canada, Bancomext (Mexico), Ministry of Finance (Japan), Board of Foreign Trade (Taiwan), Ministry of International Trade and Industry (Malaysia), Thai Customs Department (Thailand).

Codes

Furniture trade data for all countries except members of the European Union refer either to headings 94.01, 94.03 and 94.04 of the Harmonized System excluding the followings: 940110 Seats of a Kind Used for Aircraft, 940120 Seats of a Kind Used for Motor Vehicles, 940430 Sleeping Bags, 940490 Other Articles of Bedding and Similar Furnishing (Quilts, Cushions).

Furniture trade data for European countries refer to the following codes of the Combined Nomenclature: 94.01, 94.03 and 94.04, excluding the followings: 94019010 Parts of seats used for aircraft, n.e.s., 94011090 Seats for aircraft (excl. leather-covered and for civil aircraft), 94011010 Seats for civil aircraft (excl. leather-covered), 94011000 Seats of a kind used for aircraft, 94012000 Seats for motor vehicles, 94043000 sleeping bags, whether or non-electrically heated, 94049010 articles of bedding and similar furnishing, filled with feather or down (excl. mattresses and sleeping bags), 94049090 articles of bedding and similar furnishing, fitted with springs or stuffed or internally filled with any material or of cellular rubber or plastics (excl. filled with feather or down, mattress supports, mattresses, sleeping bags, pneumatic or water mattresses and pillows, blankets and covers).

In particular, when referring to "furniture parts" the following codes have been used: 94039090, Parts of furniture, n.e.s. (excl. seats, and of metal and wood), 94039030, Parts of furniture, of wood, n.e.s. (excl. seats), 94039010, Parts of furniture, of metal, n.e.s. (excl. seats), 94019080, Parts of seats, not of wood, n.e.s., 94019030, Parts of seats, of wood, n.e.s.).

2. Furniture production

Sources

Furniture production data are sourced both from Eurostat and CSIL database.

CSIL database is based on CSIL processing of Eurostat statistics, together with other sources.

CSIL data are used in long time series of furniture production and in the detail of furniture subsegments.

Even if specific differences exist when comparing CSIL and Eurostat series, this does not lead to substantial differences when assessing trends (both in cross countries comparisons and in the long term analysis).

Codes

Furniture production data cover the Eurostat NACE REV.2 Division 31 "manufacture of furniture" and the following sub-group NACE REV2 class 31.01 "manufacture of office and shop furniture", class 31.02 "manufacture of kitchen furniture", class 31.03 "manufacture of mattresses" and class 31.09 "manufacture of other furniture" and Eurostat NACE REV.1 Division 36.1 for historical data.

3. Number of companies, size and employment

Sources

Eurostat SBS, Structural Business Statistics.

4. Value added, gross operating surplus

Sources

Eurostat SBS, Structural Business Statistics.

5. Furniture consumption

Sources

Furniture consumption data are sourced from CSIL database (see below).

Furniture consumption, if not otherwise specified, is apparent consumption.

Apparent consumption is calculated by CSIL as follows: total production less total export, plus total import.

Apparent consumption is at production/import prices and thus excludes the mark-up applied from retailers.

Per capita furniture consumption, if not otherwise specified, is calculated diving total country/area consumption by total population.

6. CSIL product definition

- Office furniture: Visitor chairs without wheels, Office chairs with wheels, Executive chairs, Folding/stackable chairs, Chairs for waiting rooms, Chairs for airports, auditoriums, cinemas etc., Chairs for the community (hospitals, clinics etc.), Operative and Management furnishing systems, desks that include bases (units which can be fitted/incorporated under a desk), Partitions, Office bookcases/shelving, Filing cabinets, Cupboards and various Storage items complementary to operative workstations, Filing Systems, Wall-to-wall units (Roof-high equipped partition walls in panels, metal, plasterboard or glass), Furniture for communication areas (counters, reception, benches for auditoriums and break rooms).
- Upholstered furniture: Seats convertible into beds (excl. garden seats and camping equipment, and medical, dental or surgical furniture), Upholstered seats with wooden and metal frames.
- Kitchen furniture: Furniture of a kind used in kitchens (excl. seats), fitted kitchen units.
- Mattresses: Mattress supports (including wooden or metal frames fitted with springs or steel wire mesh, upholstered mattress bases, with wooden slats, divans) mattresses of cellular rubber (including with a metal frame), mattresses of cellular plastics (including with a metal frame), mattresses with spring interiors, other mattresses excluding watermattresses, pneumatic mattresses

• Other furniture:

- o Non-upholstered seats: Non-upholstered seats with wooden frames (excl. swivel seats), seats of wood, cane, osier, bamboo or similar materials, other seats (excl. seats for aircraft and for motor vehicles).
- o Bedroom furniture: Cupboards, drawers, beds (excluding mattresses and mattress supports), bedside tables, bedroom storage systems.
- o Dining and living room furniture: Tables, bookshelves, sideboards, and other furniture for dining-living rooms (excl. seats).
- Other furniture: Other kind of furniture for outdoor, the garden, bathroom (excl. medical, dental, surgical or veterinary, and seats), furniture for shops (incl. shop, bar and hotel fittings, modular shop fitting systems, coat stands, etc.), occasional furniture.

CSIL geographical classification

The classification of the 70 countries included in CSIL is as follows:

If not otherwise specified:

- EU refers to EU28;
- Western Europe refers to EU15: Austria, Belgium, Denmark, Finland, France, Germany, Greece, Ireland, Italy, Netherlands, Portugal, Spain, Sweden, and United Kingdom. Luxembourg data are listed together with those of Belgium in CSIL database;

- Central and Eastern Europe outside the EU refers to Bosnia Herzegovina, Russia, Serbia, Turkey, Ukraine and Russia;
- Asia and Pacific refers to China, Hong Kong, India, Indonesia, Japan, Kazakhstan, Malaysia, Philippines, Singapore, South Korea, Taiwan, Thailand, Vietnam, Australia, New Zealand (15 countries);
- Middle East and Africa refers to Algeria, Bahrain, Egypt, Israel, Lebanon, Kuwait, Morocco, Oman, Qatar, Saudi Arabia, United Arab Emirates and South Africa (12 countries);
- North America: Canada, Mexico, US;
- South America: Argentina, Brazil, Chile, Colombia, Venezuela.

- Emerging and Transforming Countries/Middle and Low income countries: Algeria, Argentina, Bosnia Herzegovina, Brazil, Bulgaria, Chile, China, Colombia, Croatia, Czech Republic, Egypt, Estonia, Hungary, India, Indonesia, Kazakhstan, Kuwait, Latvia, Lebanon, Lithuania, Malaysia, Mexico, Morocco, Philippines, Poland, Romania, Russia, Saudi Arabia, Serbia, Slovakia, Slovenia, South Africa, Thailand, Turkey, Ukraine, United Arab Emirates, Venezuela, Vietnam.

Notes:* Additional standardized information has to be included in labels of children and student furniture. **The mark of products circulating in the market of the Customs Union is required and is a signal of compliance with safety requirements listed in the Technical Regulation. ***Instructions have to be included in the product package. ****For disassembled furniture, the label is attached to the packaging. *****Information can be provided also in the official language of another state that is member of the Customs Union; trade name of the product and name of the manufacturer can be written in the Latin alphabet.
