#### 1. GENERAL MARKET SURVEILLANCE ORGANISATION AND INFRASTRUCTURE

The Malta Competition and Consumer Affairs Authority was set up to amalgamate the operations of the former Malta Standards Authority and the Consumer and Competition Division. The MCCAA was set up in May 2013 and consists of four distinct entities, namely the Technical Regulations Division, the Office for Consumer Affairs, the Office for Competition and the Standards and Metrology Institute.

The Technical Regulations Division is made up of the Regulatory Affairs Directorate, responsible for transposition of technical European regulations and directives into Maltese law and the Market Surveillance Directorate, which is the sole Market Surveillance Authority for Malta for non-food and non-medicinal products.

# 1.1. Identification and responsibilities of national market surveillance authorities

As mentioned above the Market Surveillance Directorate (MSD-TRD) within the Technical Regulations Division of the MCCAA has the responsibility to ensure that only safe non-food and non-medicinal products are found on the market in Malta, both for old approach products as well as for those products falling under the New Approach Directives and Regulations. Hence market surveillance in Malta is centralized within the MSD-TRD.

MSD-TRD currently consists of 6 persons including the Head of the directorate, 2 Scientists, 1 Engineer and 2 Product Safety Officers. It is envisaged that an additional 3 persons join the directorate in the near future.

# **1.2.** Coordination and cooperation mechanisms between national market surveillance authorities

As MSD-TRD is the sole Market Surveillance Authority for Malta, there is no need for coordination and cooperation mechanisms to be in place. Notwithstanding this fact, MSD-TRD does coordinate and cooperate with other Maltese entities responsible for the proper function of the market surveillance function, such as Customs, responsible for border control, and the Malta Communications Authority (MCA), responsible for the wireless spectrum in Malta.

# 1.3. Cooperation between national market surveillance authorities and customs

A Memorandum of Understanding has been drawn up and signed between MSD-TRD and Customs for the sharing of information and cooperation in enforcement. Apart from this formal instrument of agreement, most operations take place on an ad hoc basis with a number of contacts being established between MSD-TRD and Customs, with contacts taking place using electronic and voice communication media, primarily.

In view of the small size of the country, inspections and exchange of samples between Customs and MSD-TRD are common and have been found to be very efficient and effective, with decisions taken in a short period of time, thus proving to be a very reliable mode of operation.

Training of Customs officers by the Technical Regulations Division within MCCAA has also been common and serve a dual purpose, ie to establish the requirements of the different product types falling under the responsibility of MSD-TRD and to establish a personal contact with the colleagues within the 2 entities.

# 1.4. Rapid information exchange system - RAPEX

MSD-TRD is the National Rapex Contact Point for Malta. In view that it is also the sole market surveillance authority, communication and cooperation are very efficiently handled, thus necessitating very little bureaucracy and ensuring an efficient set up.

Notifications arising from Malta are known to all personnel within MSD-TRD as the unit is small and practically operates from one single room, thus enhancing communication and sharing of knowledge and information.

Reactions to notifications are handled by Malta by means of an email containing the information found on the Rapex portal on each individual product being forwarded to known importers and retailers, of the relevant product type, in Malta who are then expected to reply if they are either responsible and/or aware of the product being placed on the market in Malta either by themselves or by any other operator.

# 1.5. ICSMS information system

Again, having a centralised system of market surveillance in Malta, ICSMS is one of the tools used by the officers and any information therein is made known to all officers promptly and with the minimum of bureaucracy.

MSD-TRD has undertaken training on the operations of ICSMS and uses the said platform for any information required on specific products. MSD-TRD has also uploaded some products whenever it is felt that such information would be beneficial for other Market Surveillance Authorities around Europe or when the baton needs to be passed to a member state for action from their side. Other authorities involved in some sort of market surveillance, such as Customs and MCA, have also attended the same training and use ICSMS as and when required.

# **1.6.** General description of market surveillance activities and relevant procedures

The Malta Competition and Consumer Affairs Authority is responsible for the safe placing on the market of all non-food products. To ensure such safe placing, the MCCAA carries out the following operations:

• Inspections (proactive and/or reactive, seasonal and/or sectoral)

- Reaction to complaints and/or queries (from consumers, economic operators, other entities)
- RAPEX notifications (as well as other notifications, eg CPSC, ICSMS etc)
- Regulations (e.g. pesticides Maximum Residue Levels)

The MCCAA reacts to complaints originating from all possible sources, such as consumers and economic operators, and received on all possible communication media such as voice, emails, newspapers and radio and television programmes.

When a complaint is received, the contact details of the complainant are registered and a complaint report may be drawn up, giving details of the complaint, the retail outlet the product was purchased from and the importer of the product into Malta. The latter operator is contacted and requested to demonstrate compliance of the products to the applicable legislation. Further action is taken as and when required until compliance of the product is ascertained or otherwise. If the product is not shown to be compliant, measures, proportionate to the non-conformance and risk profile drawn up, are taken to ensure the products on the market are safe.

Discussions are underway with the local health Authorities to gather information about injuries encountered in Malta, so as to enable a more reliable data to be gathered for drawing up Risk Assessments and risk profiles.

When a product is found to pose a high or serious risk to consumers, and it is ascertained that traceability of the product to the consumer is possible, such as in the case of motor vehicles, the economic operator responsible for placing the said product on the market is requested to inform consumers and or users and carry out the necessary measure to prevent possible injuries. In the case of consumer products for which traceability is not possible or is felt to cause possible problems, a press release is issued through the Government Department of Information and disseminated around the Maltese public.

Penalties for infringements of the Product Safety Act and/or the Pesticides Control Act only come into force following conviction by the law courts. Both laws mentioned fall under the criminal code and the penalties therein are commensurate with other criminal legal instruments, including fines, increasing in the case of subsequent indictment following the first and prison terms.

Economic operators are expected by the Product Safety Act to inform and collaborate with the Market Surveillance Directorate in case of identification of an unsafe product. This aspect is also mentioned in communication with economic operators in the case of a Rapex notification or of other notifications of unsafe products.

# **1.7.** General framework of cooperation with other Member States and non-member states

The MCCAA is very active in joint actions undertaken by Prosafe as well as the various Adco groups. In fact, part of the National Market Surveillance programme for the subsequent year takes into account the various joint actions being held around Europe as mentioned.

Malta is also active in the exchange of officials programme operated by the EU Commission, in which colleagues from Malta and other members states visit each other to learn about specific product groups and/or directives and regulations.

The MCCAA also takes part in the Rapid Advise Forum operated by Prosafe as well and contributes towards discussions and sharing of information and knowledge amongst member states. Apart from this, the MCCAA undertakes one-to-one discussions through emails and other media forms on specific issues arising accordingly. Instances where such discussions arise are the encounter of products coming from specific member states, sharing of information on measures adopted on specific issues and also the facilitation of exchange of information between colleagues in other member states and colleagues in Malta not directly related to market surveillance.

### 1.8. Evaluation of Market surveillance actions and reporting

The National Market Surveillance Programme for the preceding year is evaluated during the time that the programme for the following year is being drawn up, so as to take into account issues which failed to materialise and the reason which such failure occurred. Moreover, during the same time, the possibility of carrying over to the following year operations which had been left undone during the previous year is examined and evaluated, so as to establish the need for a second attempt to be undertaken or otherwise drop the proposed action altogether.

The evaluations of the National Market Surveillance Programme are not made public, but the results of the programme itself are.

### 1.9. Horizontal activities planned for the relevant period

A number of dossiers involving dangerous chemicals have been taken over by MCCAA-TRD from the Malta Environment and Planning Authority during the last quarter of 2014 and 2015 will be the first full year of operations on these products. These new dossiers include PIC, POPS, packaging waste and other regulations and/or directives. Hence, apart from establishing the operations required for proper monitoring and enforcement on these new legislations, new recruits will have to be enrolled, as detailed above, and trained to cover these product types as well as other products already falling under the remit of the TRD-MSD.

A number of Taiex training initiatives have been established during the past years during which colleagues coming from member states not forming part of the European Union visit Malta for a few days in order to exchange information and knowledge on specific aspects falling under our remit, whilst also serving as a means by which they would give their views on the operational methods undertaken in Malta. This system is expected to continue also in the future.
