## **PROGRAMME FOR THE SURVEILLANCE OF PLACEMENT ON THE MARKET OF RECREATIONAL CRAFT AND THEIR COMPONENTS**

### **I. GENERAL**

Sector: manufacture and placement on the market of recreational craft and their components

Market surveillance authority: Lithuanian Maritime Safety Administration (hereinafter 'the Administration')

Review of the programme: first review in 2011, and subsequently at least once every two years

### **II. PURPOSE OF THE DEVELOPMENT OF THE PROGRAMME**

In the field of surveillance of manufacture and placement on the market of recreational craft and their components, implementation of the provisions of Regulation (EC) 765/2008 of the European Parliament and of the Council setting out the requirements for accreditation and market surveillance relating to the marketing of products.

The Programme has been developed in accordance with the provisions of Article 18(5) of Regulation (EC) No 765/2008 of the European Parliament and of the Council.

### **III. LEGISLATION REGULATING THE DEVELOPMENT OF THE PROGRAMME AND RELATED LEGISLATION**

Regulation (EC) 765/2008 of the European Parliament and of the Council setting out the requirements for accreditation and market surveillance relating to the marketing of products and repealing Regulation (EEC) No 339/93;

Order No 3-352 of 15 June 2004 of the Minister for Transport and Communications 'On Approval of Technical Regulation on the Design, Construction, Placement on the Market and Release to Service of Recreational Craft' (*Official Gazette*, 2004, No 98-3654);

Directive 94/25/EC of the European Parliament and of the Council on the approximation of the laws, regulations and administrative provisions of the Member States relating to recreational craft, as amended.

#### **IV. AUTHORITY RESPONSIBLE FOR THE IMPLEMENTATION OF THE PROGRAMME**

The Administration is designated to conduct surveillance of placement on the market of recreational craft and their components. In conducting market surveillance, the Administration shall monitor compliance by manufacturers, authorised representatives of manufacturers and importers in manufacturing or importing recreational craft and their components with the provisions of the Technical Regulation on the Design, Construction, Placement on the Market and Release to Service of Recreational Craft approved by Order No 3-352 of 15 June 2004 of the Minister for Transport and Communications and other legislation on manufacture and placement on the market of recreational craft and their components.

Within its competence, the Administration shall investigate infringements set out in the aforementioned legal act and shall notify the European Commission and other bodies authorised by Member States of the infringements detected in the course of conducting surveillance of placement on the market of recreational craft and their components.

The Administration shall cooperate with the Customs of the Republic of Lithuania and the State Non-Food Products Inspectorate.

#### **V. MEASURES FOR THE IMPLEMENTATION OF THE PROGRAMME**

To ensure the surveillance of placement on the market of recreational craft and their components, the Administration will conduct its activities by implementing the following measures: 1) preventive (pro-active) which are aimed at preventing non-compliant products from entering the market; 2) active controls which are aimed at eliminating defective products already on the market, and 3) response upon receipt of information on a defective product existing on the market.

##### **1. Preventive (pro-active) measures**

In cooperation with the Customs of the Republic of Lithuania (where an invitation is issued to perform an evaluation of the product that is in the customs warehouse), the documents and their authenticity are verified before recreational craft and their components are placed on the market. This is to ensure withdrawal from the market, ban or restriction on placing on the market of recreational craft and their components that do not comply with the requirements as set out in the legislation of the Community and the Republic of Lithuania and may pose a threat to the protection of public and consumer interests while accordingly informing the public and notifying the European Commission and other Member States thereof.

##### **2. Active controls**

Cooperation with the Customs of the Republic of Lithuania includes identification of importers of recreational craft and their components and preparation of a plan for the inspection of importers. Thus a level playing field will be created for fair competition among business operators and fair trade and honourable behaviour of economic operators towards each other will be ensured.

##### **3. Response (reactive) measures**

Complaints about the use of substandard vessels are analysed, information received from other EU Member States concerning identified defective unsafe models of recreational craft or their components is evaluated. This is done to ensure, by taking all necessary interim measures, the withdrawal from the market, ban or restriction on placing on the market and/or release to service of recreational craft or their components which, despite bearing the CE marking and being correctly designed, constructed, installed where appropriate, maintained and used in accordance with their intended purpose, may endanger the safety and health of persons, property or the environment.

The Plan for the Surveillance of Placement on the Market of Recreational Craft and Their Components for 2011 is provided in the Annex.

## **VI. IMPROVEMENT OF PERFORMANCE**

With a view to improving the performance of the Administration, coordination of its activities with the other market surveillance authorities, in particular with the Customs Department and the State Non-Food Products Inspectorate, will be strengthened. More inspections will be carried out jointly with the aforementioned authorities and cooperation will be fostered with the authorities responsible for market surveillance of recreational craft and their components of other EU Member States.

Planning of activities will include a greater emphasis on the improvement of monitoring procedures as well as analysis of potential infringement risks taking into account the risk factors in certain areas of activity following the complaints received from consumers and business operators as well as requests from other control authorities. Cooperation with state and local government authorities and with the public, education of entrepreneurs on violations of consumer rights will place a greater focus on the prevention of violations in the area of manufacture and placement on the market of recreational craft and their components.
