Dear Mr. Beyrer,

I would like to thank you for your continuous support to our Missions for Growth and to inform you that I intend to carry out a mission to Taipei from 3-5 June 2015, coinciding with the 35th edition of the prestigious international fair Computex, the largest ICT trade show in Asia and the second largest in the world.

Taiwan is our 21st trading partner with €40bn in bilateral trade last year. It is an advanced economy with many small and medium sized firms and a market of 23 million consumers with a high purchasing power. It plays a central role in the global technology and particularly in the ICT value chain. The EU is the largest foreign investor on the island but there is still scope to increase the figures. Also Taiwanese investment in the EU has enormous potential to grow.

This visit notably aims at helping our companies and in particular SMEs to operate internationally by exploiting business opportunities in Taiwan, in particular by participating in matchmaking events with local entrepreneurs.

Because of the importance of the ICT across sectors, many EU companies may find it useful to visit COMPUTEX and find business partners. It serves as a sourcing hub for hi tech and ICT procurement, new product launches and announcements in technology application, attracting more than 38,000 international visitors.

I am intending to arrive in Taipei on Wednesday 3 June 2015 in the afternoon. On 4 June, we will organise together with the Taiwan External Trade Development Council (TAITRA) a briefing meeting on "how to do business in Taiwan and in the EU" at the Taipei International Convention Center. I hope you will join me in making a presentation on how to do business in Europe, while the Taiwanese side and the European Chamber in Taiwan (ECCT) will be making presentations on the Taiwanese market and their experience.

The B2Bs will also take place at the Taipei International Convention Center. Specific meetings with companies in sectors of interest to European companies will be set up. Some sectors that are growing particularly fast in Taiwan are semiconductors, nanotechnology, electronics in general and environmental protection. Business services, machinery, energy and biotechnology can also present good opportunities.

On Friday 5 June we will visit the Hsinchu Science Park.

We are pleased to invite you to join us in making this "Mission for Growth" to Taipei a success. We welcome your participation and encourage you to advertise this mission amongst the presidents of national federations and interested CEOs/entrepreneurs.
