The following tables imprint the Greek National Market Surveillance Program (NMSP) for the year 2015, according to the requirements of the Regulation (EC) No. 765/2008. The program has been elaborated by the General Secretariat of Industry of the Ministry for Productive Reconstruction Environment and Energy with the cooperation of all Sectoral Market Surveillance Authorities.

The NMSP has been established by using the European Commission Working Paper “WP SOGS-MSG N008 ADDENDUM”.

Wherever the same legislation is mentioned under more than one market surveillance authorities, the cooperation between these authorities is understood. In addition, all market surveillance authorities cooperate with customs authorities in order to control products from third Countries entering the Community market through Greece.

In general, the approach regarding market surveillance includes both proactive and reactive type of monitoring. Proactive activities include the elaboration and realization of an annual sectoral program by each market surveillance authority for its products/sectors. Reactive activities are performed following customer complaints, denunciations etc. Monitoring activities are performed by trained employees of the surveillance authorities. Details regarding the structure of the market surveillance system and the distribution of responsibilities between the several market surveillance authorities were presented in the national programs of 2010 and 2011.

Finally, it is worth mentioning that all monitoring activities on products that General Secretariat of Industry is competent, are supported by an integrated information system, which has been entered in full operation since April 2011.
