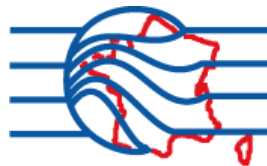

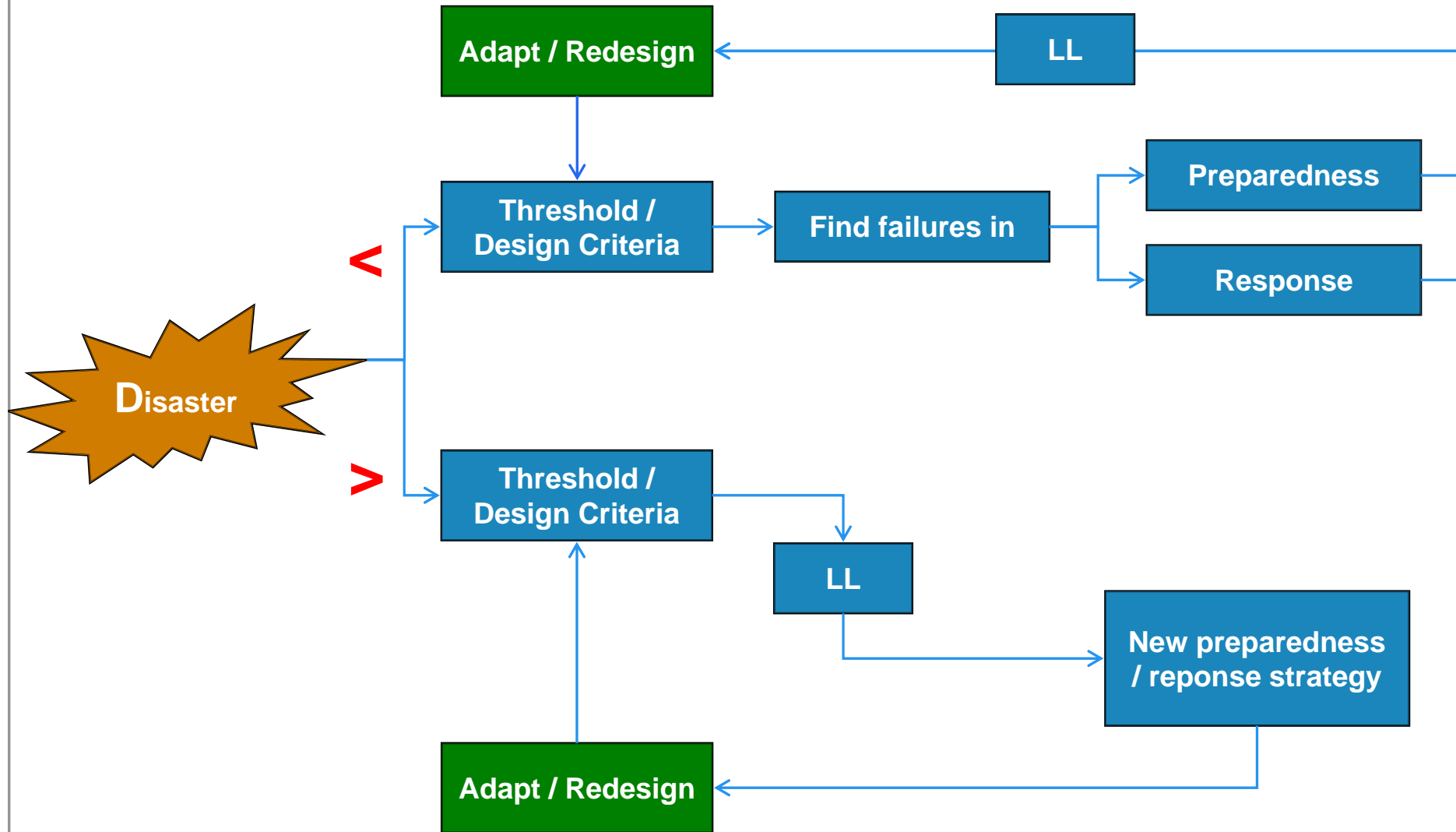
Project Description

- **Contribution** to Objective 1 of the Call: Developing knowledge-based disaster prevention policies
- **Objective:** Examine technical thresholds of preventive infrastructure regarding their resilience to major hazardous events. Identify preparedness / response drawbacks
- **Analysis of:** 13 case studies across central Europe on rare events
 - Germany, Poland, Czech Republic and France
 - Floods, Storms and Flash Floods (Elbe 2002, Aude River 1999, Hurricane on Great Mazurian Lakes etc.)
- **Extract lessons learned aimed at:**
 - determining failures (threshold or other) allowing disaster to happen
 - improving knowledge on existing technical, preparedness and response drawbacks
 - contributing to better future disaster prevention plans

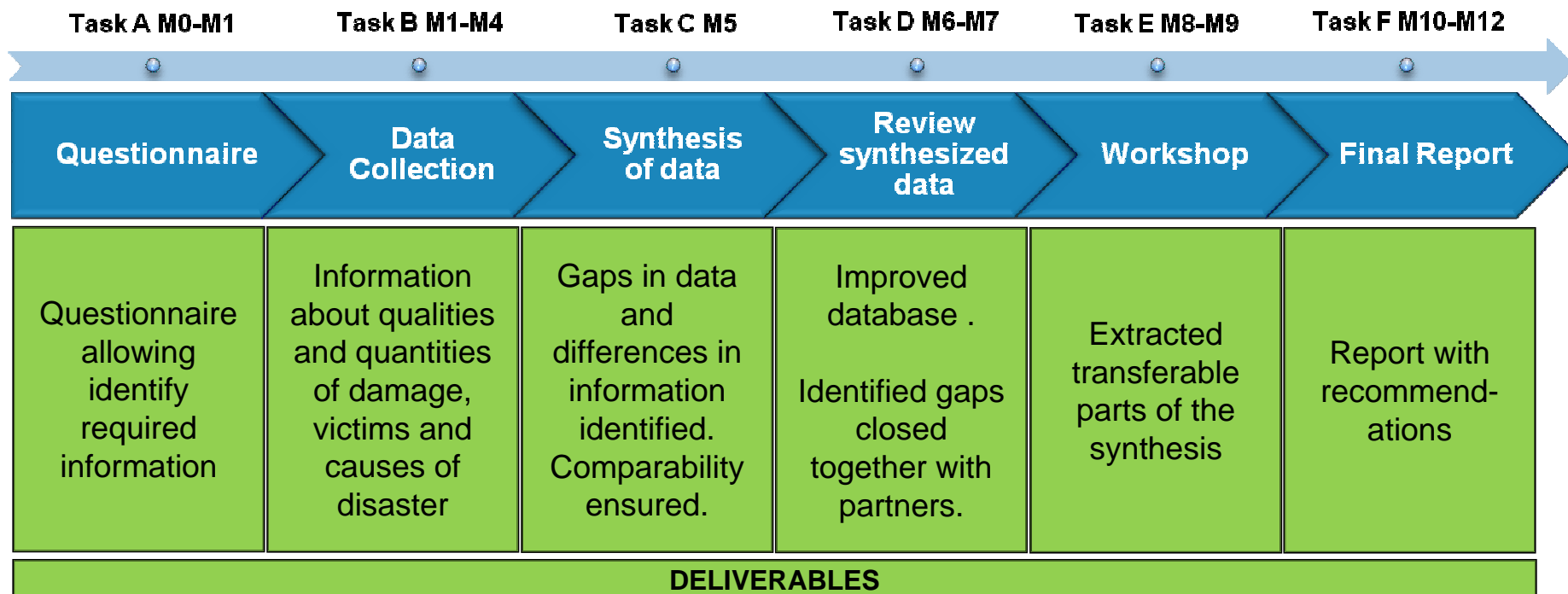

International Expert Workshop

- **Participants:** representatives of National Platforms for DRR, national Civil Protection, EC Civil Protection Department and other relevant experts
- **Objective:** improve and review synthesized information
- **Expected Outcomes:** (1) extracted transferable parts of LL, (2) causes of design criteria failures, (3) LL put into force, (4) need for adapting preventive measures and thresholds
