INTRODUCTORY REMARKS

Following the ECOFIN Council meeting of 12 July 2002, the production function (PF) approach for the estimation of output gaps now constitutes the reference method when assessing the stability and convergence programmes, starting with the 2002 set of programmes. During a "short" transition period, during which the PF method will be periodically reviewed and amended if necessary, the Hodrick-Prescott (HP) filter will be used as a backup method. For Spain the HP filter method will be used to assess the 2002 stability programme. Also Germany and Austria expressed the view that some time was needed before estimates using the production function are considered as sufficiently reliable in deriving policy assessments.

The output gaps are calculated according to both methods. The cyclically adjusted balances are calculated according to the production function approach. For Spain, Germany and Austria an exception is made and the cyclically adjusted balances for these countries are calculated on the basis of output gaps estimated according to the HP filter. In this publication, the exception is also valid for Luxembourg, as the calculation of the PF output gap requires further analysis.

Therefore, the cyclically adjusted data for aggregates are a mixture of the two approaches.

Government accounts (transactions and balances) up to 2002 have been compiled and reported to the Commission by the national statistical offices and checked by Eurostat. Figures for 2003 - 2004 are forecasts by the Commission Services (Directorate General Economic and Financial Affairs) in Spring 2003.

PRESENTATION

This document is organised in two parts. Part I shows for each Member State the figures of the government total revenue, total expenditure and net lending or borrowing. Actual GDP, potential GDP, trend GDP and output gaps are also presented *pro memoria*. For each of these accounts a decomposition is presented between actual data, the cyclical component and the cyclically adjusted data. **For the years 2000 to 2002, one-off proceeds relative to the allocation of mobile phone licences (UMTS) are included in the actual data but excluded from the cyclically adjusted data.**¹ Finally, the same data are presented at an aggregate level for the group of countries participating in the EMU as well as for the EU as a whole. The methodological reference is the European System of National and Regional Accounts (ESA95), which is, since mid-1999, the reference for the compilation of national

accounts within the European Union. From 2000 on, ESA95 figures are also the reference for the budgetary surveillance in Europe.

In Part II, three tables are presented for each specific general government account: actual data, cyclical component and cyclically adjusted data. These tables show time series since 1970 for all Member States, for the EU as a whole and for the group of countries participating from the 1st January 1999 (or 1st January 2001) in the EMU. Tables are presented according to the ESA95 system. Finally, a time series of actual GDP, potential GDP trend GDP and output gaps is also included in this part *pro memoria*.

All calculations are implemented within the framework of the corresponding DG ECFIN forecasting exercise and, therefore, they incorporate not only historical data but also forecast figures.

Aggregation for country groups is based on exchange rates.

Data in national currency for the euro-zone countries

Starting from 2002, euro-zone countries publish national series in EUR. National currency data for all years prior to the switch of the country to euro have been converted using the irrevocably fixed euro conversion rate. For presentation purposes, the currency denomination has changed, with the prefix EURO and the ISO code of the former currency (i.e. EURO-BEF for Belgium). This approach conserves the historical continuity of national series. However, cross country comparisons and aggregations should continue to be based only on historical series established in ECU up to 1998 and their statistical continuation in EUR from 1999 onwards.

CYCLICAL ADJUSTMENT OF GOVERNMENT BUDGET BALANCES BASED ON PRODUCTION FUNCTION (POTENTIAL GDP)

With a production function, GDP (Y) is represented by a combination of factor inputs - labour (L) and the capital stock (K) -, corrected for the degree of capacity utilisation (U_L, U_K) of capital and labour and adjusted for the level of efficiency (E_L, E_K) of both factors. In many empirical applications, including the Commission's QUEST II model, a Cobb-Douglas specification is chosen for the functional form. This greatly simplifies estimation and exposition. Thus GDP is given by:

$$(1) \quad Y = (U_L L E_L)^\alpha (U_K K E_K)^{1-\alpha} = L^\alpha K^{1-\alpha} * TFP$$

where total factor productivity (TFP) summarises the efficiency and the utilisation of both factors of production. With the Cobb Douglas production function TFP summarises utilisation and efficiency of both factors. TFP is implicitly defined as:

$$(2) \quad TFP = (E_L^\alpha E_K^{1-\alpha}) (U_L^\alpha U_K^{1-\alpha}).$$

Factor inputs are measured in physical units. An ideal physical measure for labour would be hours worked. Unfortunately this information is not available for all Member States and the statistical information is not easily comparable across countries. Therefore we measure labour input simply by the number of employees. This implies that any changes in working time will be reflected in the efficiency index. For capital we use a comprehensive measure which includes spending on structures and equipment by both the private and government sectors.

Various assumptions enter this specification of the production function, the most important ones are the assumption of constant returns to scale and a factor price elasticity which is equal to one. The main advantage of this assumption is simplicity. However these

assumptions seem broadly consistent with empirical evidence at the macro level. The unit elasticity assumption is consistent with the relative constancy of nominal factor shares. Also, there is little empirical evidence of substantial increasing/decreasing returns to scale.

The output elasticities of labour and capital are represented by α and $(1-\alpha)$ respectively. Under the assumption of constant returns to scale and perfect competition, these elasticities can be estimated from the wage share. The same Cobb-Douglas specification is assumed for all countries, with the mean wage share for the EU15 over the period 1960-2000 being used as the estimate for the output elasticity of labour, which gives a value of 0.63 for α for all Member States and, by definition, 0.37 for the output elasticity of capital. While the output elasticity for labour may deviate somewhat from the imposed mean coefficient in the case of individual Member States, such differences should not seriously bias the potential output results.

In moving from actual to potential output (YP), trend TFP and potential factor use must be determined. No particular theoretical model for determining trend TFP is used, instead an HP filter (with $\lambda=100$) is applied in order to extract a smooth trend for TFP. No distinction is made between actual and potential capital since a normal level of capacity utilisation is already implicitly defined by the TFP trend. The definition of the potential output contribution of employment is more involved since it is more difficult to assess the 'normal' degree of utilisation of this factor of production. Since there is no strict physical limit, the definition that we therefore apply is the level of employment consistent with non accelerating (wage) inflation (NAWRU).

The starting point for the determination of potential employment is the population of working age (POP^W) from which the trend labour force is obtained by multiplying population of working age with the trend participation rate ($PART^T$). Potential employment (LP) is then given by:

$$(3) \quad LP_t = POP_t^W PART_t^T (1 - NAWRU_t)$$

For determining the trend participation rate the HP filter is used while the unemployment trend is determined by using information on the change of wage inflation. The NAWRU is obtained as a Kalman filter estimate under the hypothesis that the deviation of unemployment from the NAWRU is negatively related to the change of wage inflation if one controls for other temporary shocks to wage inflation such as terms of trade shocks, for example. Thus a Phillips curve relationship is postulated which links the change in wage inflation ($\Delta\pi_t^w$) to the unemployment gap or the cyclical component of unemployment (C^U) plus other exogenous or predetermined variables (X_t). Other unobserved shocks are captured by the error term u_t which is allowed to be auto-correlated

$$(4) \quad \Delta\pi_t^w = \mu + \gamma X_t + \beta C_{t-1}^U + u_t \quad \text{with} \quad u_t = \sum_{i=0}^I \theta_i \varepsilon_{t-i}$$

where $C_t^U = U_t - NAWRU_t$.

Besides having predictive power for wage inflation, the cyclical component of unemployment must also obey certain business cycle restrictions:

- it should be an auto-correlated process, preferably second order;
- it should be stationary;
- it should have a sample mean of zero.

Such a process is characterised by the following equation

$$(5) \quad C_t^U = \phi_1 C_{t-1}^U + \phi_2 C_{t-2}^U + v_t$$

where stationarity requires $\phi_1 + \phi_2 < 1$. This property of cyclical unemployment, together with the HP filtered series for trend participation and trend TFP guarantee that the output gap has a mean of zero over the sample. This property is regarded as important since it limits judgmental interventions in modelling trend GDP.

After the determination of trend participation, the NAWRU and trend TFP, potential output can be calculated as

$$(6) \quad YP_t = (POP_t^W PART_t^T (1 - NAWRU_t))^\alpha K_t^{1-\alpha} TFP_t^T$$

and the output gap ($YGAP$), defined as the percentage deviation of actual GDP from potential can be decomposed into the deviation of the participation rate from trend, the unemployment gap and a TFP-gap as follows

$$(7) \quad YGAP_t = \alpha \left(\begin{array}{l} (PART_t - PART_t^T) + \\ + (NAWRU_t - U_t) \end{array} \right) + TFPgap_t$$

As can be seen from this expression, in contrast to an output gap which is entirely based on a statistical filtering procedure, the output gap based on a production function provides more information about the sources of deviations from trend.

CYCLICAL ADJUSTMENT OF GOVERNMENT BUDGET BALANCES BASED ON HODRICK-PRESCOTT FILTER (TREND GDP)

1. Methodological approach

The cyclically adjustment method based on Hodrick-Prescott filter is a simple and transparent method which provides a uniform framework for the calculation of cyclically adjusted budget balances for each of the Member states of the European Union. As the adjusted balance estimates are calculated mechanically, they do not require judgmental fine-tuning and can therefore easily be replicated.

2. A two-step procedure

This method involves two main steps. In the first step, the output trend is estimated by means of the Hodrick-Prescott filter and the output gap between the trend GDP level and the actual output is calculated.

In the second step, cyclical components of budget balances are calculated by applying the output gaps to the marginal rates of change of revenue and expenditure with respect to GDP. Finally, the cyclically adjusted budget balances are obtained by deducting the cyclical component from the actual government budget balances.

2.1 Estimating trend GDP and output gaps

To obtain estimates for the output trend, the Hodrick-Prescott filter is applied to the actual output series. The Hodrick-Prescott filter

minimizes the sum of squared deviations of actual output around its trend subject to a constraint on the variation of the growth rate of trend output. The filter applies weighted moving averages to the actual output series to obtain trend GDP estimates – rather than a simple arithmetic moving average – and therefore it allows for a better filtering of actual output data.

However, the Hodrick-Prescott filter – as all moving-average-based methods – is sensitive to the lack of information at the extremes of the series to be analysed. When the extremes of the series are approached, the filter becomes asymmetric as no observations are available at one side of the reference year.

DG ECFIN has decided to solve the end point bias problem by means of a mechanical projection of the actual output series provided by an automatic selection of the best fit time series model in order to ensure a symmetric filtering of the trend at the end of the series.

Series of GDP in volume are extended with the projected GDP figures and the Hodrick-Prescott filter is applied in order to obtain the output trend. Finally, the output gap is calculated as the difference between the actual level of GDP in volume and that of trend GDP, expressed as a percentage of trend GDP.

2.2 Estimation of revenue and expenditure elasticities

The cyclical component of budget revenue and expenditures is obtained by multiplying the output gap with the budgetary sensitivity to revenues and expenditures to GDP. Budgetary elasticities for the different relevant expenditure and revenue categories have been calculated by OECD².

The revenue sensitivity is a weighted average of four component revenue elasticities (personal income taxes, corporate taxes, social security contributions and indirect taxes), whereby the different components are weighted by the relative share of each category in total revenue.

The expenditure sensitivity takes only into account government transfers to households to cover costs related to unemployment as they are the only expenditure category which is assumed to react ‘automatically’ to cyclical fluctuations.

2.3 Calculation of cyclically adjusted budget balances

The application of the marginal sensitivity of revenue and expenditure to the output gap allows for the determination of the cyclical component of the deficit. The cyclically adjusted budget balance is obtained by subtracting the cyclical component from the actual budget balance.
