




## BUSINESS AND CONSUMER SURVEY RESULTS

### May 2015: Economic Sentiment stable in both the euro area and the EU

In May the *Economic Sentiment Indicator* (ESI) remained unchanged in both the euro area (at 103.8) and the EU (at 106.4).<sup>1</sup>

#### Euro area developments

The stabilisation of euro-area sentiment resulted from increasing confidence in the services, retail trade and construction sectors being offset by consumer confidence decreasing for a second month in a row. Confidence in industry edged up only marginally compared to the last month. Amongst the largest euro-area economies, the Netherlands (+0.9), France (+0.7) and Germany (+0.5) saw economic sentiment improving, whereas sentiment declined slightly in Italy (-0.4) and remained unchanged in Spain.

The marginal improvement in **industry confidence** (+0.2) was due to managers' more optimistic *production expectations*, which slightly outweighed their worsened assessment of *stocks of finished products*; views on the *current level of overall order books* remained broadly stable. Of the questions not included in the confidence indicator, the assessment of *past production* deteriorated, while views on *export order books* remained stable. The improvement in **services confidence** (+0.8) was driven by managers' brighter *demand expectations* and their significantly better assessment of the *past business situation*; the assessment of *past demand* remained broadly stable. **Consumer confidence** weakened (-0.9) due to worse assessments of the *future general economic situation*, *future unemployment* and *future savings*, while consumers' expectations of their *financial situation* remained broadly unchanged. The marked rise in **retail trade confidence** (+2.2) reflected more positive views on all its components: the adequacy of the *volume of stocks*, managers' assessment of the *present business situation* and, in particular and similarly to industry and services, of the *expected business situation*. The positive development in **construction confidence** (+0.5) resulted from an upward revision in managers' assessment of the level of *order books* which was only partly offset by weaker *employment expectations*. The important deterioration (-4.3) in **financial services confidence** (not included in the ESI) was due to less positive appraisals of the *past business situation* and *past demand*, while financial managers' *demand expectations* remained broadly unchanged.

**Employment plans** saw an upward revision in industry, services and retail trade while they were revised downwards in the construction sector. **Selling price expectations** increased in industry and construction, while they remained broadly stable in services and slipped only in the retail trade sector. Also consumer price expectations picked up in May.

#### EU developments

In line with euro-area developments, the headline indicator for the EU remained unchanged. Concerning the two largest economies outside the euro area, sentiment worsened in Poland (-1.5) while remaining broadly stable in the UK (+0.1). Services and retail trade confidence improved and consumer confidence decreased in line with the euro area. EU industry confidence edged up slightly more markedly than in the euro area and confidence in construction decreased. Finally, confidence in financial services fell in line with the euro area.

Employment expectations differed from the euro-area results in the retail trade sector, where EU managers reported a downward revision. Price expectations were in line with those for the euro area except for the service sector, where managers expected prices to decrease.
