

In March, the *Economic Sentiment Indicator* (ESI) registered the third consecutive drop in both the euro area (by 0.9 points to 103.0) and the EU (by 0.7 points to 104.6).¹

Euro area developments

The deterioration of euro-area sentiment was due to lower confidence among consumers as well as managers in the services and construction sectors. Confidence in industry remained broadly unchanged, while it improved slightly in retail trade. Amongst the five largest euro-area economies, the ESI weakened significantly in Italy (-2.4) and France (-1.8) and, less so, in the Netherlands (-0.9) and Spain (-0.4). German sentiment remained largely flat (-0.1).

Broadly stable **industry confidence** (-0.1) resulted from managers' virtually unchanged assessments of the expected production and the current level of overall order books. Only the adequacy of the stocks of finished products was assessed more cautiously. Of the questions not included in the confidence indicator, the assessment of past production improved, while views on export order books deteriorated. Weakening **services confidence** (-1.2) was driven by grimmer assessments of developments over the past three months, notably the past business situation and past demand. Demand expectations, by contrast, eased only slightly. **Consumer confidence** dropped (-0.9) as a consequence of growing pessimism among consumers about the future general economic situation and, to a lesser extent, their future financial situation and future savings. Only assessments of future unemployment remained virtually unchanged. Slight improvements in **retail trade confidence** (+0.4) were caused by more positive views on the present and expected business situation that were only partly outweighed by a worsened assessment of the adequacy of the volume of stocks. **Construction confidence** slipped (-3.2) due to deteriorating assessments of both the level of order books and managers' employment expectations.

Financial services confidence (not included in the ESI) dropped (-4.0), driven by more negative appraisals of all three components (*past business situation*, *past demand* and *demand expectations*).

Employment plans saw significant downward revisions in construction and services, while they remained virtually unaltered in industry and retail trade. **Selling price expectations** increased in industry and construction, while they remained broadly stable in services. By contrast, retail trade selling price expectations, as well as consumer price expectations dropped.

EU developments

The somewhat slighter decrease of the headline indicator for the EU (-0.7) can be mainly attributed to the largest non-euro area economies, which saw sentiment either broadly stable (Poland, +0.2) or improving (UK, +1.0). At sector level, developments deviated from the euro area in so far as industry confidence increased slightly while retail trade remained broadly flat.

Employment expectations deviated from euro-area developments mainly in industry (slight upward revision) and retail trade (downward revision). Similarly, price expectations were broadly in line with the euro area, except for retail trade, where selling price expectations firmed, rather than dropped.

¹ The business confidence indices for France and Austria were slightly revised compared to the February press release, causing an upward revision of a decimal point of the ESI for the euro area (to 103.9) and the EU (to 105.3).










The issues of January, April, July and October also include the quarterly survey results for the manufacturing industry and consumers. The April and November issues also include the investment survey results.

The data of the surveys is processed by DG ECFIN's Unit Economic situation, forecasts, business and consumer surveys (A3), Sector Business and consumer surveys and short-term forecast.
