#### The Overall Context of SGEI Policy in the EU

#### The Multi-Faceted Nature of SGEL

- Networks/ Infrastructures
- Essential Services/ Strategic Sectors
- Macroeconomically Important
- Monopolies/ Oligopolies
- Traditionally Close to Governments (even if Privately Owned)

#### But the Regulatory Framework for SGEI has changed over time

- EU Policy has been an Important Catalyst
- Even if Some Incumbent States and Firms have been Cautious/Reluctant

#### How far has this changed SGEI?

- New Incentive Structures? From Cost Plus to Cost Cutting?
- What are Implications for SGEI's Historic Commitments
- Just another Commodity/Service?
- Or do Important Cohesion (Social and Regional) and other Obligations Persist?

- The Progress of Reform (Liberalisation)
- The Consequences of Reform (Impact on General Economic Interest)

#### The Reform Process

- Drawn Out Negotiations/Problematic Implementation
- Subsidiarity: EU Rules for Liberalisation but Greater MS Discretion for PS/USO

#### A Wider Definition of EU Activities Required?

- Commission Actions (Competition Decisions, Cohesion/Structural Funds)
- European Parliament Activities (and ECSC/CoR)
- Court Judgements

- National Policy Developments (and Regulator Activities)
- Scope for Open Coordination: good (and bad?) practice

#### Industry performance and market integration: Is the Market Working?

EU Rules = Market Liberalisation? Why Not?

- Incumbent Market Power
- National Regulatory Weakness
- Close Government Relations

#### Market Structure

- A Missing Indicator? Industry Profitability
- Have Cost Cuts Been Passed On to Consumers?
- Is the SQ a "Happy Medium" (some competition but some "public obligation")
- ....or the Worst of all Worlds? (no public obligation and market power)

#### Airlines as the Exception

- Where are the Ryanairs of Electricity?
- ....And do we want them?

Will European Oligopolies be any Better than National (near) Monopolies?

## **Distributive Effects and Customer Satisfaction: Equity Effects**

What Would Full Liberalisation Mean for SGEI?

- Price Cuts All Round?
- ...or Cross Subsidies Fully Unravelled?
- Which Consumers Would Gain the Most
- What about "Losers": More or Less USO/PSO (or other Mechanisms)?
