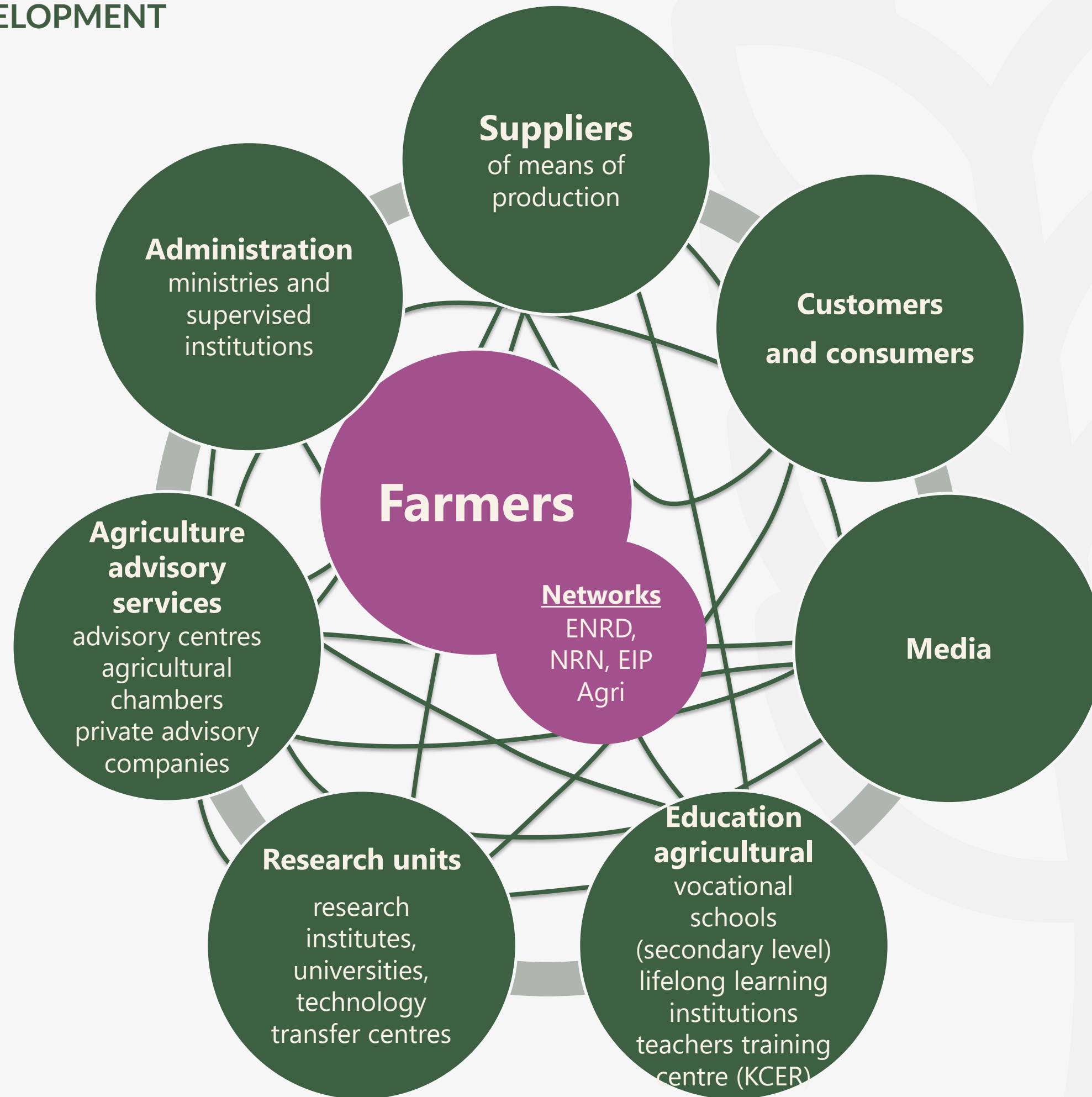

Strengths of the AKIS in Poland

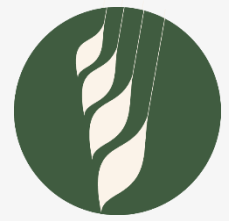
- The existing system of agricultural research, education and agriculture advisory services, BUT...
- A wide range of training and advisory services for farmers, offered by experienced public advisory staff, BUT...
- Relatively high authority of the research and teaching staff
- Relatively high farmers' trust in advisers
- Developing network of contacts and cooperation between partners of the AKIS (in particular within the Network of Innovation in Agriculture and Rural Areas)
- Growing involvement of researchers and agricultural advisors in implementation of research projects



Needs for the AKIS development

1. Improving the qualifications and skills of staff involved in the knowledge and innovation transfer and exchange
2. Ensuring the availability of professional advisory and training services for farmers and rural residents
3. Strengthening cooperation between partners of the AKIS
4. ICT platforms development and increase of the use of ICT tools in the exchange of knowledge and innovation





RDP 2014-2020 measures to support knowledge and innovation

1. Network for Agricultural and Rural Innovation (SIR)
2. Cooperation - 35 contracts signed and 154 operational groups applying for funding. Further calls are planned
3. Trainings for farmers – about 142.500 participants (including current calls)
4. Demonstrations – two calls under preparation
5. Trainings for advisers – more than 3.700 trainees and almost 730 participants in postgraduate studies
6. Advisory services for farmers - more than 47.700 recipients

CAP Strategic Plan - knowledge and innovation transfer

1. **Cooperation - EIP OG !!!**
2. Comprehensive advisory services programmes
3. Training and information for farmers and rural residents
4. Improving qualifications and skills of agricultural advisors, teachers and researchers
5. CAP Network supporting the AKIS system (e.g. thematic networks, preparation of interactive projects, networking the OGs, promotion of good practices, communication platform)
