#### **Roberto Scalacci Tuscany Region**

Director for Agriculture and Rural Development at the Government of Tuscany Region since 2015. Agricultural expert and Graduated in Law from the University of Siena. Previous roles and positions: Director of the Representative Office at the EU of the Italian Farmers' Confederation (CIA) in Brussels and member of the POCC of the COPA (2008-2015). President of the Tuscan Young Farmer Association (2000-2006) and national Vice President (2005-2006). Member of the National Committee of PDO and PGI wines of the Italian Ministry of Agriculture (2003-2008) and Officer at the Tuscany section of CIA (1997-2008). Technician at the CIPA.AT (Center for Agricultural Professional Education and Technical Assistance) (1992-1996). Author of articles and publications on agri-food and European policies (since 1996) and Winner of the "Antico Fattore" International Literary Prize of the Georgofili Academy (2009).



#### **Hugo Almeida**

#### **European Commission, DG Agriculture and Rural Development**

Hugo Almeida finalised his studies in economics in 1997 and after a first working experience in the private sector in Portugal, decided to try an international career. In 2000, during the Portuguese Presidency of the European Council becomes a trainee in the recently created Co-decision unit. In the second half of 2000 starts working in the United Nations Mission Interim in Kosovo (UNMIK) as Budget and Finance Officer where he stayed until end of 2002. In 2003 he joins the European Commission and starts working in the Budget unit of DG AGRI where he stayed for seven years and worked in different files like direct management expenditure and direct aids. In 2010 moves to the Direct aids unit where among other things is appointed as Head of the Single Payment Scheme sector. In 2013 is appointed Deputy Head of the Unit responsible for the Rural development programs of Spain and Portugal where he stayed until January 2022. Currently he is Deputy Head in the unit "Rural areas and Networks" which is responsible for the implementation of the Long-term vision for EU's rural areas, the networking activities related with the implementation of the CAP strategic Plans, innovation and knowledge exchange as well as the horizontal coordination within DG AGRI in the area of broadband.



#### **Patrizia Pitton**

#### **European Commission, DG Agriculture and Rural Development**

Patrizia Pitton is an agronomist graduated from University of Turin in Italy. As officer for the region Piemonte, she already had experience in Organic Farming and Integrated Pest management and other agro-environmental measures dating back to the beginning of 1990.

She joined the European Commission in 2001, working as inspector at the Food and Veterinary Office. From 2005 to 2018 she worked as legislative and policy officer in the Unit Pesticides and Biocides of General Direction Health and Food Safety with focus on EU legislation concerning plant protection products, in particular Regulation (EU) No 1107/2009 and EU Directive 2009/128 on the sustainable use of pesticides. #### Thomas Snellman **REKO**

Thomas Snellman is the founder of the REKO movement that was established in Ostrobothnia, Finland, in 2012. He is a farmer who converted his own farm into organic production 32 years ago – according to himself the best decision he ever made. Thomas is also the founder of the first organic committee in The Farmers Union in Finland, and in 2001–2015 he worked as a certified organic controller at Evira, the Finnish Food Authority. The list of his commissions of trust is long, here are a few examples: Member of the international working group "Logistics for short Circuit Agriculture" 2014-2015, "Nordic Food Entrepreneur of the year" in Copenhagen, Denmark 2017, "The countryside profile of the year" in Finland 2018 and a keynote speaker at the 11:th European IFOAM Conference in Vienna 2018. Since 2021 he is representing Finland in the management team in the EU-funded project agroBridges, which aims to build bridges between consumers and producers. Today Thomas Snellman is a well known name all over the world – thanks to REKO. His simple, but clever concept has spread to more than 20 countries and over 2,5 million people are members of a REKO ring. She successfully applies methods of sustainable organic farming and permaculture in creating a sustainable business model in the production of certified organic dairy products and ice cream – gelato type – with a closed cycle of animal selection, production of organic raw materials, production of the final product and its implementation.
