Rob Peters

European Commission, DG Agriculture and Rural Development

Rob Peters joined the European Commission in 1988 and has mostly worked on policy analysis, development and implementation in the field of agriculture and rural development in DG AGRI. Since 1st of January 2014 he is head of the newly created Research and Innovation unit, AGRI-H5, with responsibility for agricultural research and the European Innovation Partnership for agricultural productivity and sustainability.



Jeroen Dewulf

Ghent University

Jeroen Dewulf graduated in 1998 as a veterinarian from the Faculty of Veterinary Medicine of the Ghent University, Belgium. He immediately started working as researcher at the Herd health department of the faculty. In 2002 he finished his PhD on the epidemiology and control of classical swine fever. In that same year he received a master of science degree in veterinary epidemiology from the University of Utrecht, the Netherlands (Cum Laude). He became diplomat in the European College of Veterinary Public Health in 2005.

Since 2006 he is associated professor in Veterinary Epidemiology at the **Faculty of Veterinary Medicine of the Ghent University**. In 2014 he was appointed as full professor in Veterinary Epidemiology. His main research interests are quantitative epidemiology and control of zoonoses with a specific emphasis on antimicrobial resistance and antimicrobial use in animal production as well as the prevention of epidemic and endemic diseases with a focus on the application of **biosecurity measures**.



George Gunn

George Gunn is Professor of Population Medicine and Zoonoses at Scotland's Rural College (formally SAC), is a Research Team Leader and Head of Veterinary Epidemiology based at Inverness, Scotland, UK. He is current Director of the Scottish virtual Centre of Expertise on Animal Disease Outbreaks (EPIC). He is also a Visiting Professor in Veterinary Epidemiology at University of Glasgow.

As a research project manager working at national and international levels George has formed part of the senior management teams for the EC BVD Network, EC ParaTB Tools Project and led a Defra (UK) funded project 'An



integrated approach to biosecurity on UK cattle and sheep farms; evaluating existing measures for endemic diseases against exotic threats'. He has extensive experience of working with industry and helped initiate several cattle health programmes including HI-Health, Premium Cattle Health Scheme and Cattle Health Certification Standards (CHeCS). He also helped establish abattoir based pig health surveillance schemes within the UK George is increasingly involved in senior level policy development. With others he has pioneered new approaches which combine epidemiology with socioeconomic factors to examine how infectious diseases fit within the biological, economic and social context of farming and the human food chain. www.epicscotland.org
