Vassil Groudev

Ministry of Agriculture and Food, Bulgaria

Vassil Groudev was born on May 5, 1980 in Plovdiv, Bulgaria. He graduated the French Language School in Plovdiv and has a master's degree in law from the Law Faculty of the University "Franche-Comté" in Besançon, France. He has specialized European Cooperation at the Wageningen Business School, Netherlands.

From April 2006 to August 2013 Vassil Groudev occupied different positions in the State Fund Agriculture. From April 2006 to December 2008 he was an expert in Direct Payments Department.
