Anikó Seregélyi

European Commission, DG Agriculture and Rural Development

Anikó Seregélyi is policy officer at the European Commission, Directorate-General for Agriculture and Rural Development (DG AGRI) Research and Innovation unit.

She started her career at the European Commission DG TAXUD in 2007. In March 2015 she joined DG AGRI Research and Innovation Unit, European Innovation Partnership team. Among her current responsibilities are activities and events related to the EU-wide EIP-AGRI network (Focus Groups, workshops, seminars) and the EIP-AGRI contract management.

Prior to joining the Commission, she worked as EU project manager for the Hungarian Science and Technology Foundation in Budapest. She was responsible for several research supporting projects in the 5th and 6th RTD Framework Programme and for researchers' mobility issues.

Anikó Seregélyi studied Geography at the Eötvös Loránd University Budapest and has a master in European Studies, Aachen University, Germany.



Zsolt Feldman

Deputy State Secretary for Agriculture, Hungarian Ministry of Agriculture

Dr. Zsolt Feldman is responsible for EU agricultural subsidies, direction of market provisions and national agricultural subsidies, the management of agricultural product paths and any professional issues related to agricultural production, and coordinates the implementation of the Common Agricultural Policy (CAP). Under his professional governance in the past years the agricultural mitigation system and the agricultural research system have been extensively reformed and the interbrach organization system has been established. Besides the management of different agricultural sectors, such as swine, horse, fruit and vegetable farming, he is responsible for the professional leadership of the Agricultural and Rural Development Agency, the National Agricultural Research and Innovation Centre, the Research Institute of Agricultural Economics and the national stud farms.





Sirpa Karjalainen

European Commission, DG Agriculture and Rural Development

Sirpa Karjalainen works as policy officer at the European Commission, Directorate General for agriculture and rural development in the 'Research and Innovation" unit. Agronomist and economist by academic background, she has been working on rural development-related issues since 1988 in Finnish Ministry of Agriculture and Forestry. Since 1994 as planning and managing EU rural development programmes with the responsibility of national legislation and measures which concern business aid, investments and development projects as well as Leader – approach included in the RDP of mainland Finland. The responsibilities have been rural strategy planning, legislative work, cooperation in the governmental and regional level concerning especially the Partnership Agreement comprising all ESI funds.
