
### FEFAC in a nutshell

### The main role of the feed industry - *a vital link in the food chain -*

- To get sustainable competitiveness of the livestock industry through safe ,efficient and competitive diets
- Providing efficient diets for animals through in-depth nutritional know-how
- Comprehensive knowledge of nutritional characteristics and nutrient values of feed ingredients - accurate assessment of animals nutritional needs
- Challenge : meeting the global growing demand for animal proteins with limited availability of resources and with the need to reduce pressure on the environment




# Main criteria for purchasing feed ingredients (protein sources)

- Feed and Food safety at the first place
- For the nutritionist/formulator :
  - well definied nutrients
  - amino acids profile and digestibility
  - absence of anti-nutritional factors
- For the buyer
  - competitive price and conditions
- For the feed mill manager
  - availability throughout the year



#### **Protein sources**



Protein content of major feed ingredients above 15% protein



### **FEFAC key messages**

- Supports of developing EU wide solutions to enhance competitive production of vegetable protein sources
- Industrial background is basic in value transformation
- Availability of industrial by-products reduces pressure on land compared to dedicated feed crops
- There should be a place between niche market approaches and EU wide mainstream options



### **EU protein crops**

- The compound feed manufacturer has a role to play in regional initiatives
- Coordination of research for local initiatives should enable economy of scale.
- The overall efficiency of potential new solutions should be assessed
