The Commission has been preparing proposals for Community action to implement these provisions, which have now been issued (see Communication COM (2000) 368 of 16 June 2000, "Proposal for a decision of the European Parliament and of the Council establishing a programme of Community action to encourage cooperation between Member States to combat social exclusion ".)

Funding for these proposals is provided by 1999 budget line B3-4112 as preparatory measures in accordance with the inter-institutional agreement of 17 July 1998 on legal bases and implementation of the budget. Projects were selected on the basis of the criteria published in the Guidelines for the call for proposals, after assessment by independent external experts and a Commission selection committee. A total of 64 projects were financed to a total Community contribution of EUR 7,329,166.33.

This document provides informal summary information on each of the projects selected on the basis of the information provided with their applications.
