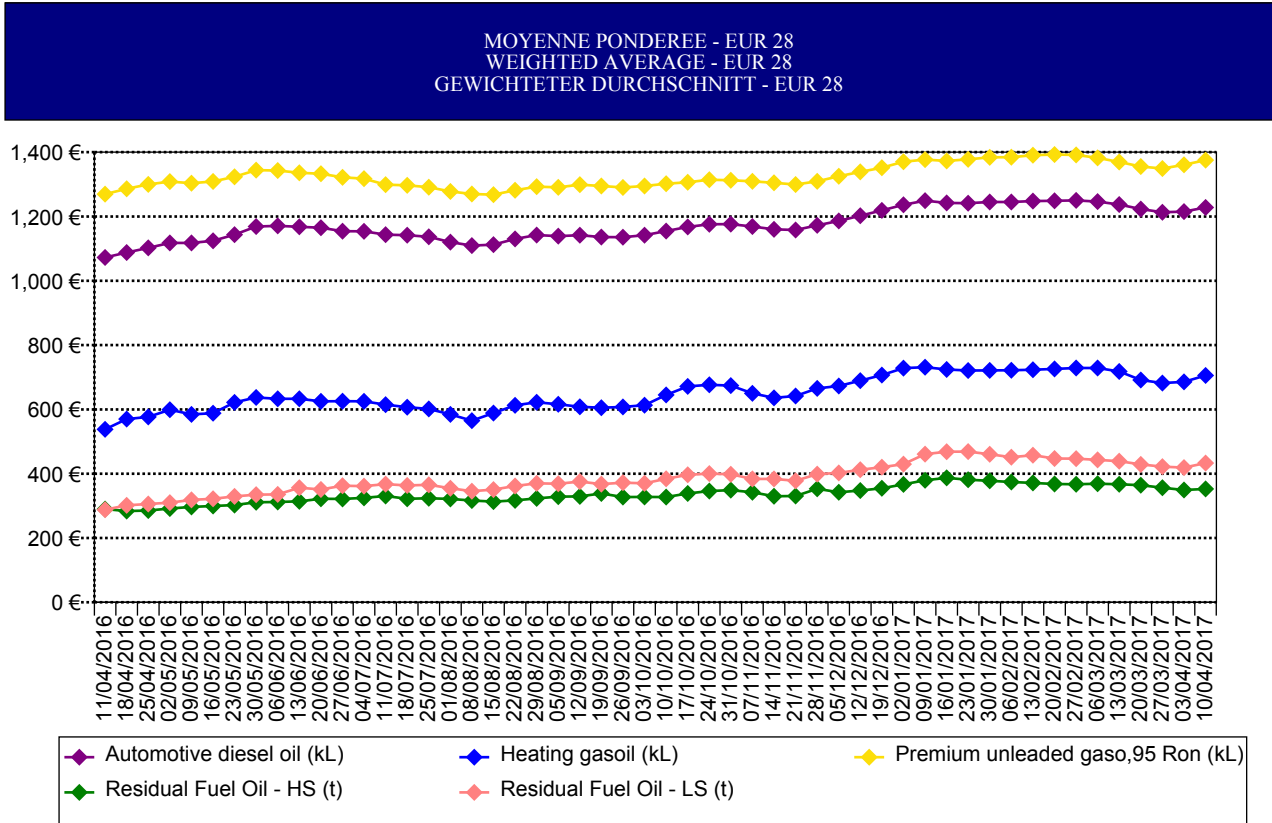

For Greece the disposal period of heating gas oil begins mid-October and ends in April.
