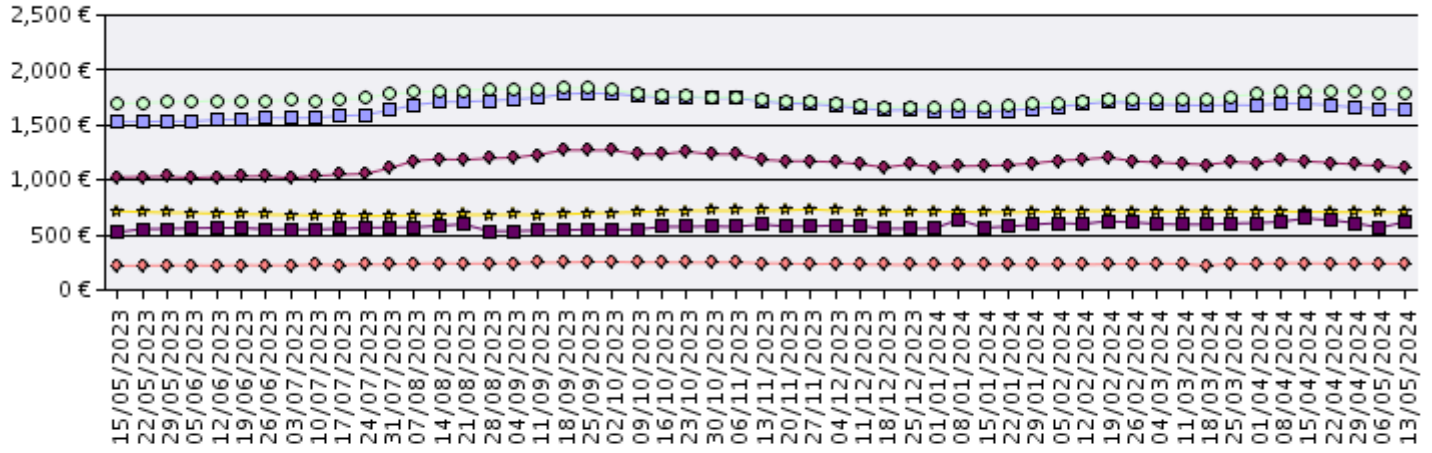

For Greece the disposal period of heating gas oil begins mid-October and ends in April.

As from 26/03/18 only one company in Ireland reports Residual fuel Oil –LS which is significantly cheaper.
