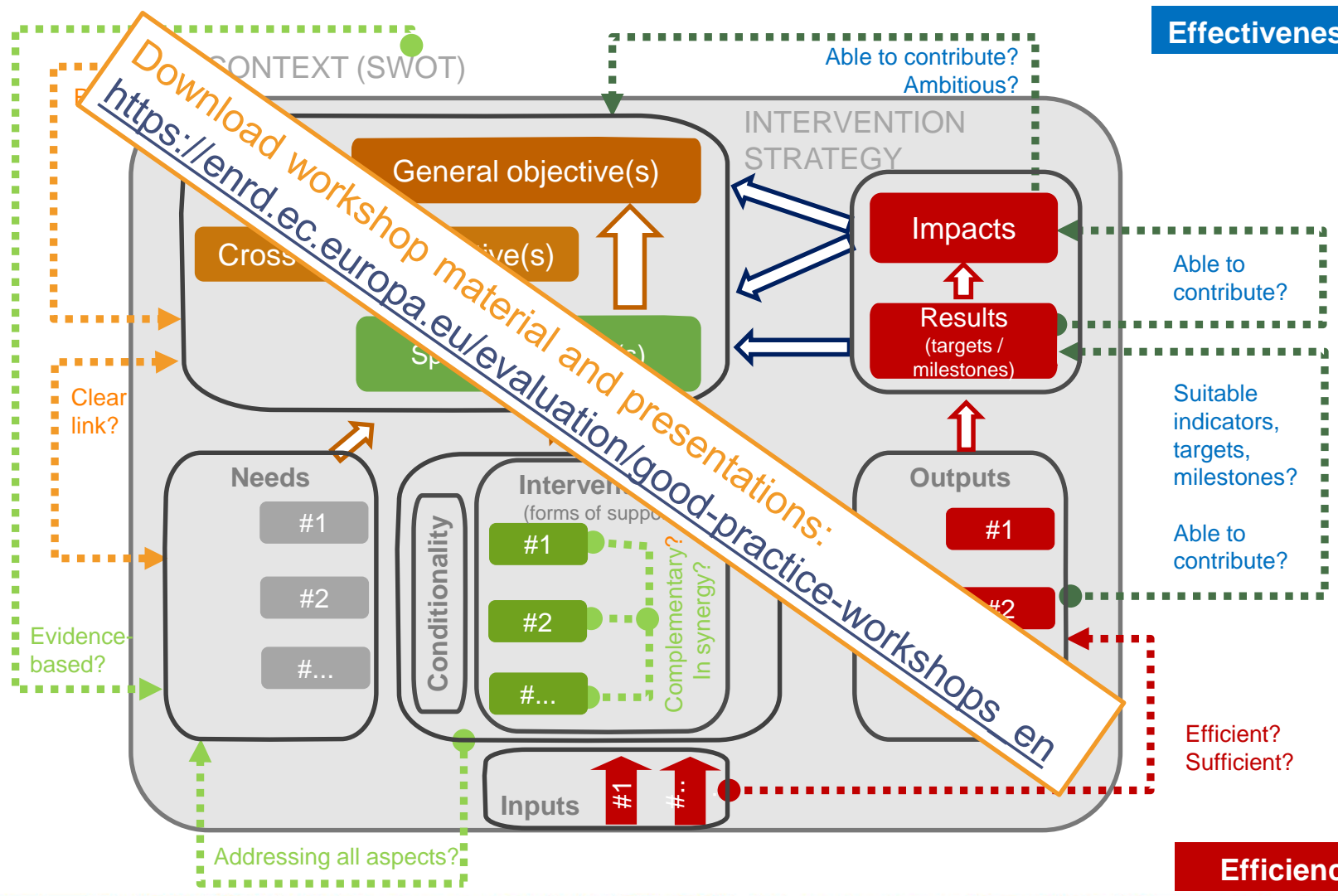

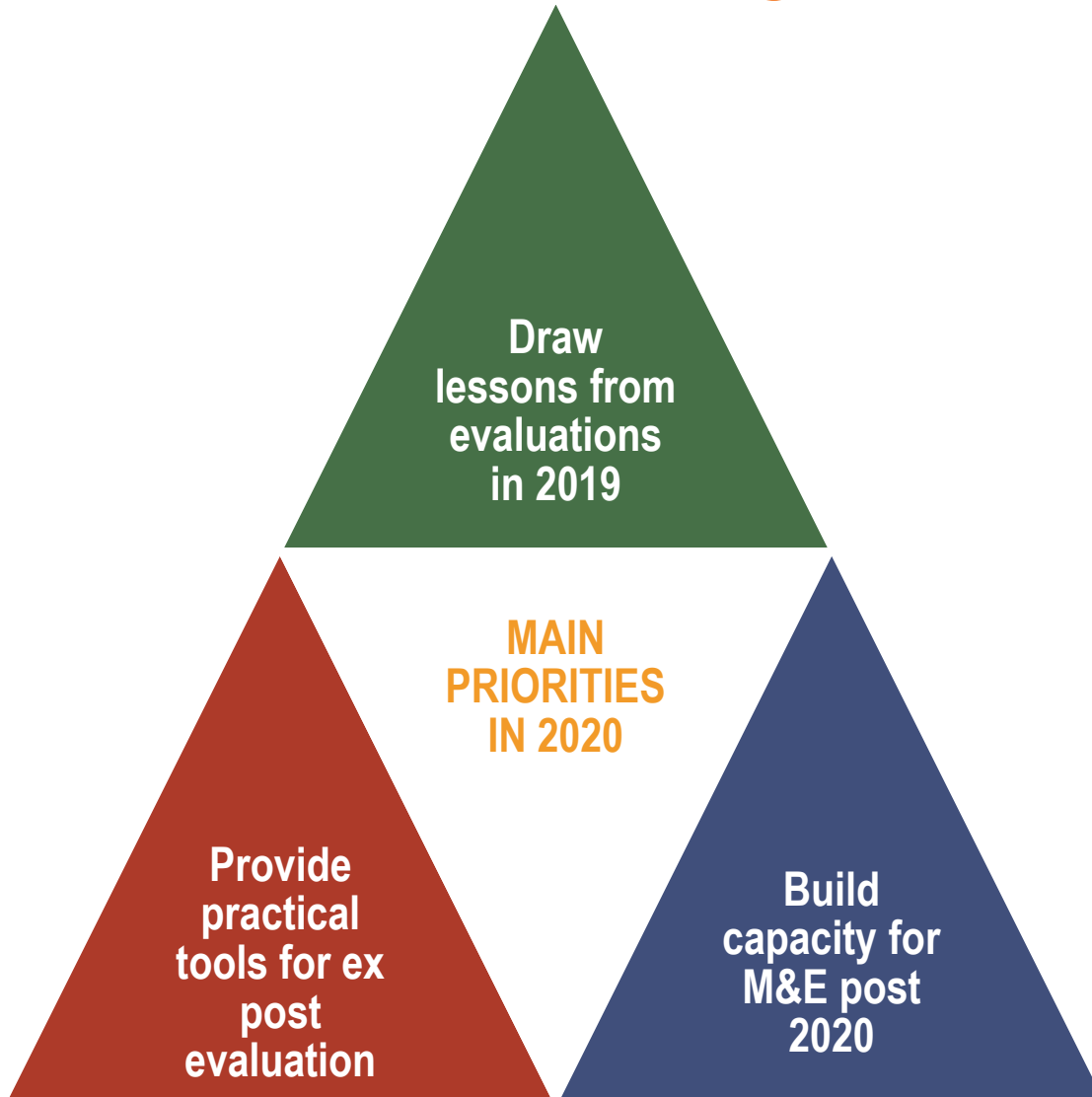

Ex post evaluation of RDPs 2014-2020: learning from practice

Objectives

- Address **weaknesses** in assessment of RDP achievements
- Improve calculation of **complementary result and impact indicators**
- Tackle **emerging issues** in the assessment of priority areas (e.g. environment, climate)

- Set of **complementary tools** for ex post evaluations
- **Update of existing guidance**, if needed

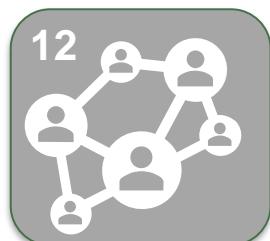


Improving evidence-based RDP evaluations in view of the ex-post

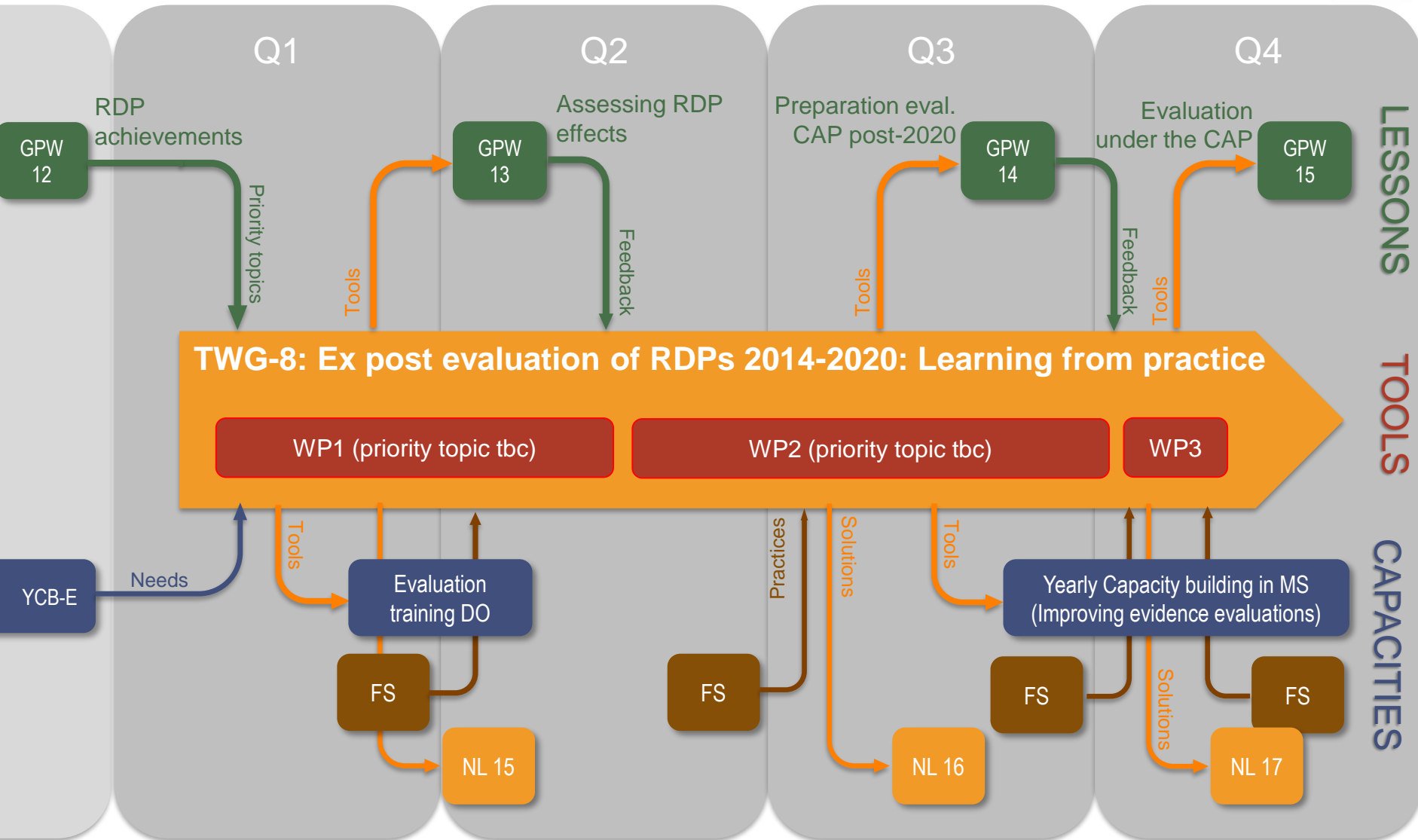
