## **Implementation of Cork 2.**

- Cork 2 offers a vision for EU rural areas
- It emphasises the partnership principle in programming; better targeting of the entire CAP to clearly defined objectives, the need to ensure accountability of our policies.
- Rural and Agricultural policy must interact within the wider context of national and regional strategies, focussing on complementarity and coherence of policies
- Rural Proofing: macro and sectorial policies must pay attention to impacts and implication on rural areas
- The upcoming communication on the "Modernisation and Simplification of the CAP".
- Summary of actions and fora where Cork will be fed in: Cork 2.0 Action Plan
  published on DG AGRI web site.





#### From Cork 2.0 Declaration to action

- Improve public awareness of the potential of rural areas
  - Activities of the European Network for Rural Development, e.g. workshops on farm resilience, rural business innovation, green economy etc.
  - National rural networks
  - Policy debates and discussion papers
- Prosperity of rural areas
  - Conference in June in Ireland on digital innovation hubs
  - Work with Member States and the EIB on better use of financial instruments and the possibilities offered under EFSI







#### From Cork 2.0 Declaration to action

- Invest in rural areas
  - EU initiative for smart villages joint project between several Commission departments
  - Conference in Lisbon in October to discuss what Rural Development Policy can do to stimulate innovation and digitisation
  - Potential offered by the bio-economy build on the lessons of the European Innovation Partnership
- A living countryside
  - Work with Commissioner Vella on sustainable use of water
  - Initiatives starting in Member States on rural community plans looking at improved energy use, circular economy and food processing leading to more tourism activity and a higher attractiveness of rural life
  - Community Led Local Development





#### From Cork 2.0 Declaration to action

- Result-oriented and simple policy
  - Working group set up in DG AGRI
- Future of the CAP
  - Public consultation process just ended
  - · Internal Commission work on various policy scenarios is ongoing
  - Conference on 7 July 2017 to present findings of the public consultation
  - · Commission Communication to follow later this year



## **Smart village concept**



- Attract young people
- Improve job opportunities
- Ensure basic services and infrastructure
- Develop the potential offered by improved connectivity and digitisation of rural areas
- Ensure a balanced territorial development
- Improve the quality of life in rural areas







## **Smart Village Action Plan**

- Compiles actions to develop villages and countryside
- Focuses on policy tools supported by EU funds and helping villages to become "smart"
- Introduces digital technologies for rural businesses, in view of supporting entrepreneurship and enhancing quality of life
- Combines operations and actions of several Commission departments dealing with rural and agricultural policy, regional policy, transport, and connectivity
