Potential use in evaluation of the CAP

- Can be used to **calculate PMEF 1.26 or 1.27 and other new indicators** at the micro and farm level related to the Farm to Fork targets (notably the target to 'ensure food security, nutrition and public health, making sure that everyone has access to sufficient, safe, nutritious, sustainable food')
- Allows access to **farm practices on fertiliser and pesticide use**, so information can be used to evaluate the contribution of such practices to food and health quality
- Makes data from different sources available through the interoperability of existing databases (data for all CAP Objectives)
- Offers access to new data that can address evaluation questions for significant policy interventions, e.g. **product quality data or crop data**, pertaining to food security
- Data on **crop types and crop production capabilities** to assess the diversity and resilience of food systems (small farms)

Potential use in evaluation of the CAP

- *A method for assessing the contribution of small farms to local food systems and nutritional security.*
 - *Improving farmers' position in the food chain (PMEF 1.08), if the evaluator wants to assess the impact of supporting short supply chains*
 - *Responding to consumer demand for quality food (PMEF 1.29), if the evaluator want to assess the consumer demand for local and fresh food*

- *To use for scenario analysis in the context of an ex ante evaluation for assessing the potential of small farms and small farm businesses to contribute to food security.*

FACEPA - Methodology for assessing the impact of adopting organic farming on farms' economic and environmental performance

Potential use in evaluation of the CAP

- *A method to evaluate the cost difference between organic and conventional farming using FADN data.*
- *Useful in an ex ante context to assess the benefits of organic farming for a sustainable food system, including access to nutritious and sustainable food (Farm to Fork strategy).*

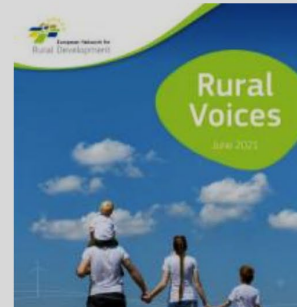
