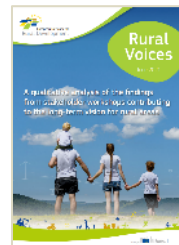
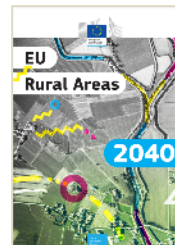

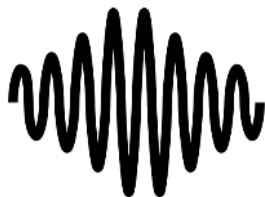
OBJECTIVES

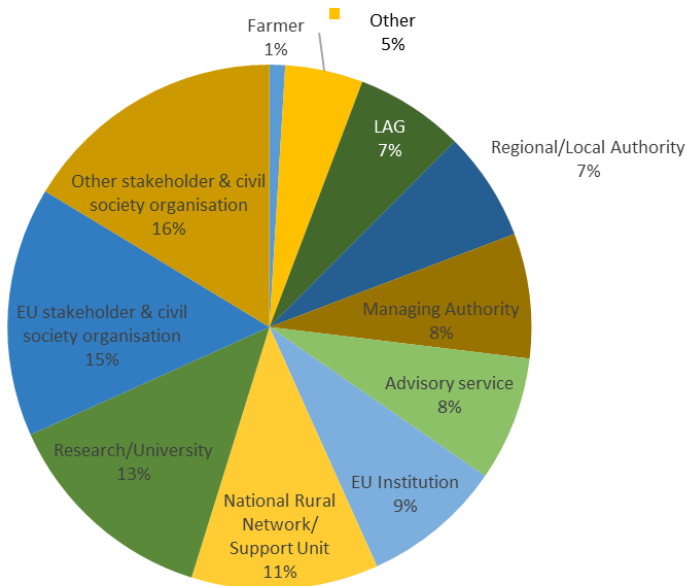
