- Brings together over 25 Roma organisations from across Europe.
- Functions as liaison between Roma organisations and European decision makers, policy makers and institutions.

#### Framework Partnership Agreement DG EMPL 2014-2017

- Assess impact of EU funding, specifically ESF
- Strengthen the role of Roma NGOs in policy delivery
- Fact-finding and evidence based advocacy



## 2014:Synthesis Paper on LEADER and ART 7.2

- LEADER did not reach out to Roma due to the focus on agriculture
- -> in Romania, Bulgaria and Slovakia over 50% of Roma live in rural areas, while not possessing land or being employed in agri-businesses
- Roma inclusion should be integral and horizontal part of the Local Development Strategy investing in equal citizenship for all
- -> Promote principles and approaches for real Roma participation in CLLD



## **Community-Led Local Development funding tool:**

Why ERGO Network invests in CLLD, because it has:

- Bottom-up approach: Involvement of local actors with a clear incentive to reach out to hard to reach groups –such as Roma
- -> Animation and community organizing
- Unique funding tool: Flexible, innovative, transparent –all conditions to invest in local democracies
- -> In countries with a large number of Roma, (local) democracies are weak



# **Work with our members on CLLD**

- Focus om Bulgaria, Hungary, Romania, Czech Republic and Slovakia both Urban and Rural CLLD
- Empower Roma groups to take part in the LAGs structure, participate in the Local Development Strategy and monitor the performance of the LAG
- Advocate towards Ministries and Management Authorities to set the right conditions so that Roma can Participate

- Develop (participatory) monitoring tool and mapping
- Build relations with National RDN
  - -> Workshop Romania 2015
