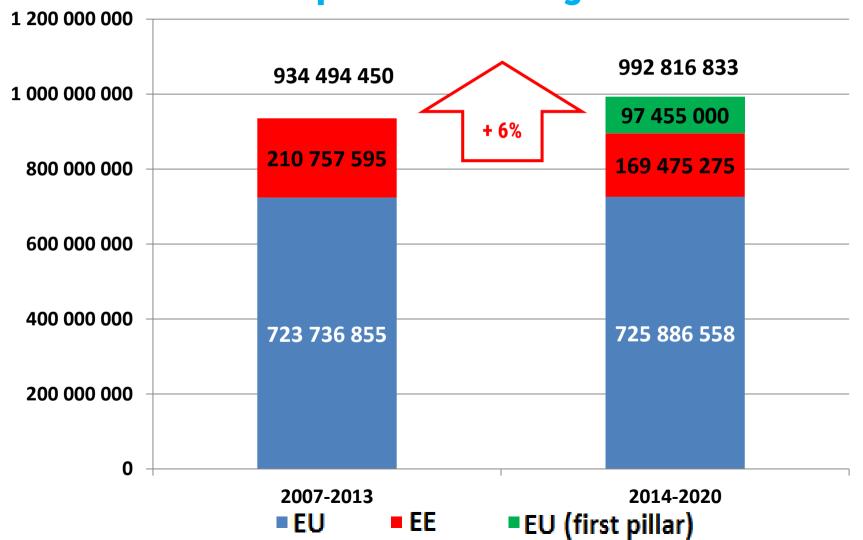

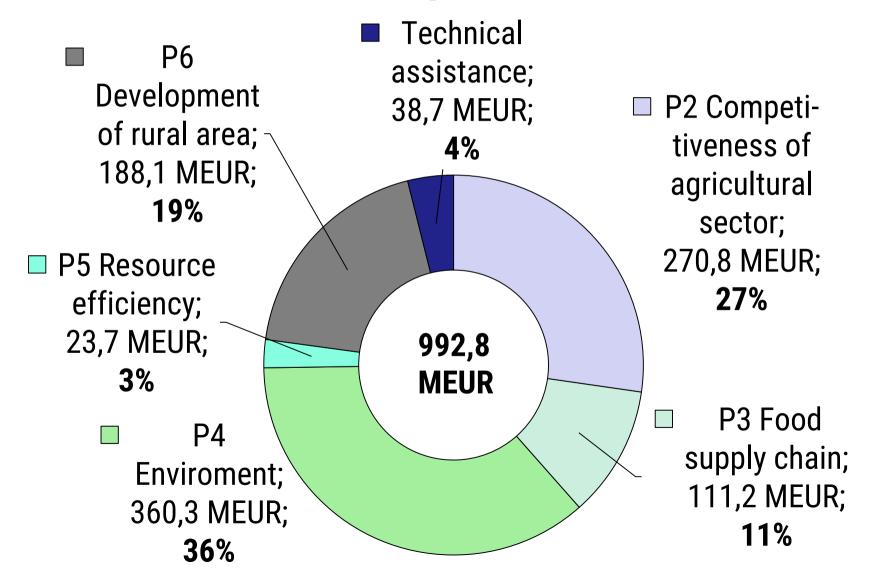

- **29** are implemented, legal acts are ready and calls for applications have been held
- **2** are still under preparation
 - 3.1 Support for the participation in quality schemes of agricultural products and foodstuffs (from 2018)
 - 10.1.2 Regional water protection support (from 2018)
- + 2 not yet in RDP
 - 14 Animal welfare: sub-measure for pig farms with liquid manure technology (slatted floors and straw do not fit)(from 2019)
 - 17 "Risk management", 17.1 "Crop, animal and plant insurance payments" (from 2019)

At the moment we are preparing the 3rd amendment to our RDP

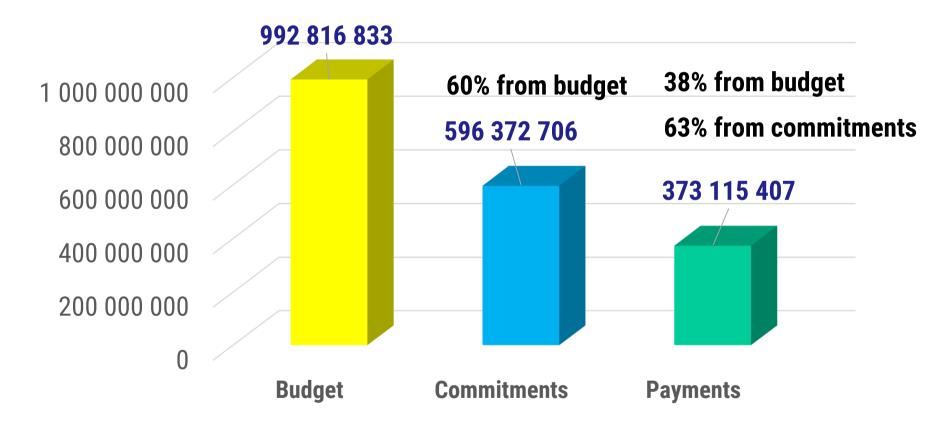

Implementation of some key measures (1)

- M4.1 Investments into improving the performance of agricultural holdings (2A)
 - opened in Feb 2015, <u>5 calls for applications</u> so far (also in Aug 2015, Dec 2015, March 2017, Dec 2017, next scheduled for Nov 2018)
 - 80% of budget committed, 34% paid out
- M4.2 Investments into processing and marketing of agricultural products (3A, 5B, 6A)

- opened in June 2015, has 4 sub-measures, in total <u>8 calls for applications</u> so far (next 4.2.1 in June, 4.2.2 and 4.2.3 in Nov 2018)

- 68% of budget committed, 15% paid out

• M4.3 - Investments into development and maintenance of infrastructure (2A)

- opened in Oct 2015, has 2 sub-measures, in total <u>6 calls for applications</u> so far (next in Oct 2018)

- **49%** of budget committed, **19%** paid out

• M6.1 - Setting up of young farmers (2B)

- opened in Oct 2016, <u>2 calls for applications</u> so far (also in Apr 2017, next one scheduled for Aug 2018)

- 41% of budget committed, 32% paid out

Implementation of some key measures (2)

• M6.3 - Development of small farms (2A, 6A)

- opened in Feb 2015, <u>4 calls for applications</u> so far (in Aug 2015, in Apr 2016, in Apr 2017, next one scheduled for Aug 2018)

- 64% of budget committed, 64% paid out
- M6.4 Support for the diversification of rural economy towards non-agricultural activities (5C, 6A)

- opened in Apr 2015, <u>2 calls for applications</u> so far (also in Aug 2016, next in May 2018)

- 49% of budget committed, 22% paid out

- M10.1.1 Support for environmentally friendly management (4)
 - opened in May 2015, <u>3 calls for applications</u> so far (every year in May)
 - 50% of budget paid out
 - 449 000 ha of area under contracts (95% of envisaged target area)
- M10.1.7 Support for the maintenance of semi-natural habitats (4)
 - opened in May 2015, <u>3 calls for applications</u> so far (every year in May)
 - 46% of budget paid out

Implementation of some key measures (3)

- M11 Organic farming (4)
 - opened in May 2015, <u>3 calls for applications</u> so far (every year in May)
 - 52% of budget paid out
- M12.2 Natura 2000 support for private forest land (4)

- opened in Apr 2016, <u>2 calls for applications</u> so far (also in Apr 2017, next in Apr 2018)

- 41% of budget paid out

• M14 - Animal welfare (3A)

- opened in May 2015, <u>3 calls for applications</u> so far (in Apr 2016, in May 2017, next in May 2018)

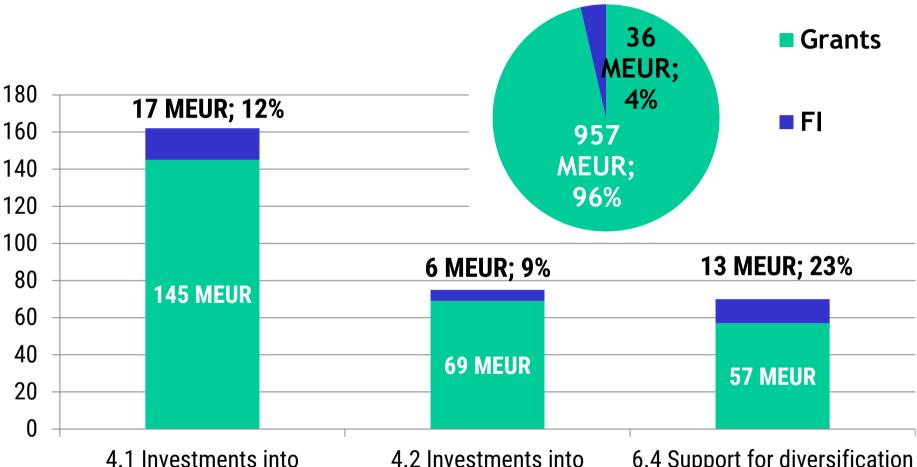
- 53% of budget paid out

• M19 – Support for LEADER local development (CLLD) (6B)

- opened in Oct-Nov 2014 (preparatory support), fully opened in March 2016 (approval of strategies, first calls for applications in LAGs);

- 67% of budget committed, 22% paid out.

Diferences in financial instruments and Grants

- Conditions for grant and FI for the same measure are not the same
- Grant conditions are more restrict, it concerns:
 - target group
 - types of activity
 - support rates
 - aid schemes
- Combination of FI and grant is allowed if the sum of grant and the FIs gross grant equivalent for the same project is less or equal to:
 - 1. amounts of support or support rates stated in the **annex II** of the regulation **1305/2013** for this measure
 - 2. total amounts for the period stated in the **Estonian RDP** for this measure
