Functionality and Responsiveness


Smaller OPERATIONAL group

- STANDARD TEXT used for all similar Commission
 Groups since 2010 (SEC(2010) 1360 final)
- Assembly is <u>not a decision-making</u> body
- Few organisation points to allow a smooth functioning
- Additional to operation points defined by Implementing Decision 2014/825/EU

Ensure coordination between the ENRD and the EIP-AGRI network


Provide the STRATEGIC FRAMEWORK for the activities of the ENRD and of the EIP-AGRI network


