

## The EU Ecolabel for Campsites

The EU Ecolabel, which is the only sign of environmental quality that is both certified by an independent organisation and valid throughout Europe, presents a unique opportunity to satisfy your customers' expectations.

Often located in pleasant but fragile locations, campsites can put pressure on water and energy resources and threaten local biodiversity through inappropriate waste management.

Increased environmental requirements and awareness, and the need for environmentally-friendly campsites to stand out from the crowd, all argue in favour of using the EU Ecolabel.

Labelling tourism services with environmental awards allows guests to recognise the company's efforts in protecting the environment and improving its quality.

Campers love nature and prefer campsites that support an intact environment. # Putting the EU Ecolabel on your campsite means that it has the following assets:

- Limited energy consumption
- Limited water consumption
- Reduced waste production
- Favouring the use of renewable resources and of substances which are less hazardous to the environment
- Promoting environmental education and communication

The EU Ecolabel applies to campsite services which provide pitches equipped for mobile lodging structures within a defined area. In this defined area, campsite services may also offer other accommodation facilities suitable for the provision of shelter to lodgers and collective areas for communal service. Services provided within that defined area may also include the provision of meals and leisure activities by the camp site management or ownership.

Criterion **Expectations** Commission Decision of 2009/564/EC of 9 July 2009 Step MANDATORY ECOLOGICAL CRITERIA Before-service At least 50% of electricity used for all purposes shall come from renewable energy sources Energy phase (when applicable). • No oil with S content > 0.1% and no coal as an energy source. Coal for decorative fireplaces is allowed. If new heat generating capacity is installed within the duration of the Ecolabel award, it shall be a high efficiency cogeneration unit, a heat pump or an efficient boiler. • Efficiency of boilers shall be measured according to Directive 92/42/EC. Existing cogeneration units shall comply with the definition of high efficiency in Directive 2004/8/EC. • Boiler efficiency > 88% as measured according to Directive 92/42/EEC. Any air conditioning system bought within the duration of the EU Ecolabel award shall have at least Class A efficiency according to Directive 2002/31/EC. • Appropriate window insulation. At least 80% of all light bulbs and 100% of light bulbs that are situated where they are likely to be turned on for more than 5 hours a day shall have an energy efficiency of class A as defined in Directive 98/11/EC. Compliance to national legislation and local building codes related to energy efficiency and energy performance of buildings Only use of appliances powered with renewable energy sources to heat outside areas. Before-service Water saving Water flow from tap or shower < 9L/minute. phase Appropriate waste bins in toilets. Appropriate systems to avoid continuous flushing in urinals. #### **OPTIONAL ECOLOGICAL CRITERIA (Points system)**

Whereas all the mandatory criteria above must be fulfilled if applicable, another set of optional criteria have been defined with a points system. A minimum of 20 points is required in the optional criteria section. If the campsite also offers other accommodations suitable for the provision of shelter to lodgers as part of its services, then the minimum score is 24. The total score required shall be increased by 3 points for each additional services offered, i.e food services, leisure/fitness activities, green areas. If the leisure/fitness activities consist in a wellness centre, the score required shall be increased by 5 points, instead of 3.
