- 2. Own dairy products used by dairies as raw materials of the same dairy industry for the production of other dairy products.
 - a) Fresh products: drinking milk, buttermilk, cream, fermented milk and drinks with a milk base, and other fresh dairy products;
 - b) Processed products: concentrated milk, powdered dairy products, butter and other yellow dairy products, cheese, processed cheese, casein and caseinates, whey and other dairy products (specify);
 - Skimmed milk and buttermilk returned to farms: quantity of skimmed milk and buttermilk returned to the farm (mainly for animal feed). Whey returned to the farms is entered under code 27 (271,272,273);
