# Country notes – UK

The United Kingdom has not established residence permits register. Statistics provided are mainly based on passengers given leave to enter the UK in selected categories. According to the British national authorities, data are estimated from a combination of information due to be published in the Home Office Statistical Bulletin 'Control of Immigration: Statistics, United Kingdom' and unpublished management information.

## **RP1 - First permits issued for family reasons**

Third country nationals joining an EU citizen:

These figures are the initial recognition of right to reside by non EEA nationals. The figures reflect persons issued documents under the 2004/38/EC/Directive as initial recognition of right to reside as a family member of a EEA national; standard practice is that all grants of this permission to stay are for a period of 5 years. Other documents may be used for the same purpose so this data will exclude those who choose not to apply. Those people aged under 18 have been estimated as being children.

Third country nationals joining a non EU citizen:

## **RP3 - First permits issued for remunerated activities**

Permits issued for Subsidiary protection are always valid 6 months unless the individual is an unaccompanied child, in which case they are granted permission to stay up until they are aged 17.5.
