1 Nature of the tasks:

The mission of the Eurostat's unit F5 is to be the leading provider of high quality statistics on education, health and social protection and foster the production and dissemination of the statistical information needed to design, implement, monitor and evaluate related policies in the European Union.

In the area of public health statistics, there are three annual data collections based on administrative sources: two on health care and one on causes of death. Under the supervision of the responsible European Commission official, the expert will contribute to the work on the validation and dissemination of the results from the three data collections within unit F5 'education, health and social protection statistics'.

The main tasks comprise the evaluation of the quality of the annual data and the validation of the main results in co-operation with Member States as well as analysis and dissemination of the results. The work involves also the development of policy indicators, in close collaboration with DG SANTE and DG EMPL (Commission's DG in charge of education and employment). OECD and WHO are as well

important stakeholders regarding methodological support for the improvement of health care statistics.

Depending on the profile of the candidate the work could also involve the modernisation of the IT tools linked to the data validation/dissemination in collaboration with Eurostat IT department.

2 Main qualifications:

a) Eligibility criteria

The following eligibility criteria are to be fulfilled by the candidate in order to be seconded to the Commission. Consequently, the candidate who does not fulfil one of them will be automatically eliminated from the selection process.

- Professional experience : at least three years' experience in administrative, legal, scientific, technical, advisory or supervisory functions which can be regarded as equivalent to those of function groups AD;
- Seniority : at least one year by your employer, that is having worked for an eligible employer (as described in Art. 1 of the SNE decision) on a permanent or contract basis for at least 12 months before the secondment;
- Linguistic skills: thorough knowledge of one of the EU official languages and a satisfactory knowledge of another EU official language to the extent necessary for the performance of the duties.

b) Selection criteriadiploma:A university degree in economics, social sciences and/or statistics.

- professional experience: Experience in statistical databases and data dissemination is desirable.

- language(s) necessary for the performance of duties: Good command of English is necessary. French would be an asset.

3 Submission of applications and selection procedure

Candidates should send their application according **Europass** CV to the format (http://europass.cedefop.europa.eu/en/documents/curriculum-vitae) in English, French or German only to the Permanent Representation / Diplomatic Mission to the EU of their country, which will forward the applications to the competent services of the Commission within the deadline fixed by the latter. Not respecting this procedure or deadlines will automatically invalidate the application. Candidates are required not to add other documents (such as copy of passport, copy of degrees or certificate of professional experience, etc). If necessary, these will be requested at a later stage. Candidates will be informed of the follow-up of their application by the unit concerned.

4 Conditions of the secondment

The secondment will be governed by the **Commission Decision C(2008)6866 of 12/11/2008** laying down rules on the secondment to the Commission of national experts and national experts in professional training (SNE Decision). This decision is available on <u>http://ec.europa.eu/civil_service/job/sne/index_en.htm</u>. The SNE will remain employed and remunerated by his/her employer during the secondment. He/she will equally remain covered by the national social security. Unless for cost-free SNEs, allowances may be granted by the Commission to SNEs fulfilling the conditions provided for in Art. 17 of the SNE decision.

During the secondment, SNEs are subject to confidentiality, loyalty and absence of conflict of interest obligations, as provided for in Art. 6 and 7 of the SNE Decision.

If any document is inexact, incomplete or missing, the secondment may be cancelled.

5 Processing of personal data

The selection, secondment and termination of the secondment of a national expert requires the Commission (the competent services of DG HR, DG BUDG, PMO and the DG concerned) to process personal data concerning the person to be seconded, under the responsibility of the Head of Unit of DG HR.B4. The data processing is subject to the SNE Decision as well as the Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data.

Data is kept by the competent services for 10 years after the secondment (2 years for not selected or not seconded experts).

Data subjects may exercise their right of access to data concerning them and the right to rectify such data by applying to the controller, in accordance with Article 13 of the Regulation on the processing of personal data. The candidate may send complaints to the European Data Protection Supervisor edps@edps.europa.eu.
