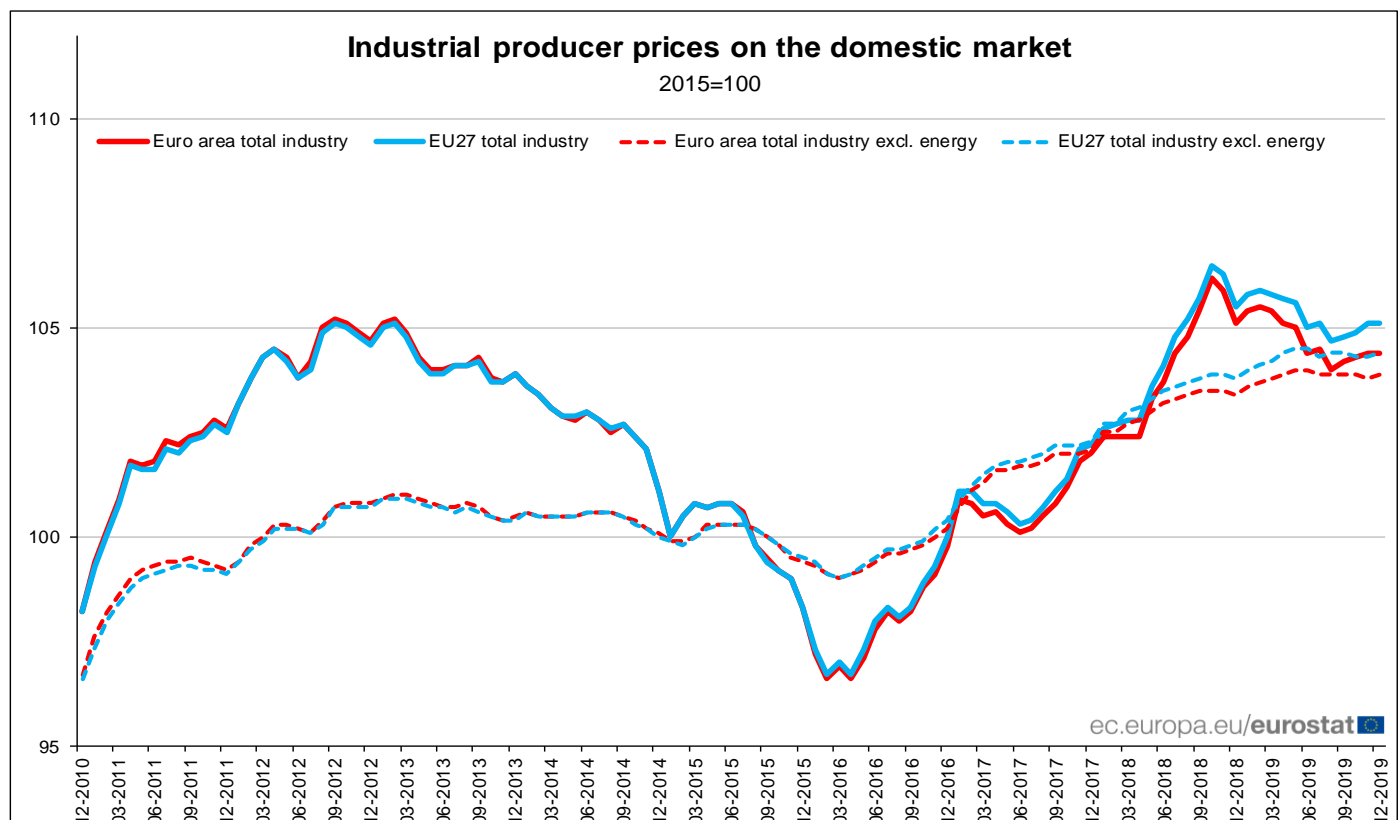
## December 2019 compared with November 2019

# Industrial producer prices stable in both euro area and EU27

In December 2019, compared with November 2019, industrial producer prices remained stable in both the **euro area** (EA19) and the **EU27**, according to estimates from **Eurostat, the statistical office of the European Union**. In November 2019, prices increased by 0.1% in the **euro area** and by 0.2% in the **EU27**.

In December 2019, compared with December 2018, industrial producer prices decreased by 0.7% in the **euro area** and by 0.4% in the **EU27**.

The average industrial producer prices for the year 2019, compared with 2018, increased by 0.7% in the **euro area** and by 0.9% in the **EU27**.



### Monthly comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in December 2019, compared with November 2019, rose by 0.5% for non-durable consumer goods and by 0.1% for capital goods, while prices decreased by 0.1% for intermediate goods and for durable consumer goods and by 0.5% in the energy sector. Prices in total industry excluding energy rose by 0.1%.

In the **EU27**, industrial producer prices rose by 0.5% for non-durable consumer goods and by 0.1% for capital goods, while prices decreased by 0.1% for intermediate goods and for durable consumer goods and by 0.5% in the energy sector. Prices in total industry excluding energy rose by 0.1%.

The highest increases in industrial producer prices were recorded in the **Netherlands** and **Romania** (both +0.5%), and **Greece** (+0.4%), while the largest decreases were observed in **Estonia** (-1.3%), **Portugal** (-1.0%) and **Finland** (-0.7%).

### Annual comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in December 2019, compared with December 2018, decreased by 4.0% in the energy sector and by 1.1% for intermediate goods, while prices rose by 1.3% for durable consumer goods, by 1.5% for capital goods and by 2.1% for non-durable consumer goods. Prices in total industry excluding energy rose by 0.5%.

In the **EU27**, industrial producer prices decreased by 3.1% in the energy sector and by 1.0% for intermediate goods, while prices rose by 1.4% for both capital goods and durable consumer goods and by 2.3% for non-durable consumer goods. Prices in total industry excluding energy rose by 0.6%.

The largest decreases in industrial producer prices were observed in **Italy** (-3.1%), **Estonia** and **Portugal** (both -2.6%), while the highest increases were recorded in **Greece** (+4.7%), **Bulgaria** (+4.5%) and **Romania** (+4.4%).

### Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU27) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

As of 1 February 2020, the United Kingdom is no longer part of the European Union. Information on dissemination of European statistics after Brexit can be found on [Eurostat website](#).

### Methods and definitions

The **index of producer prices** shows (in the national currency of the country concerned) changes in the ex-works sale prices of all products sold on the domestic market, excluding imports. Euro area and EU indices refer to overall weighted price changes. The figures are not calendar day or seasonally adjusted.

Total industry covers [NACE rev.2](#) sections B to D + E36.

### Revisions and timetable

Compared with data issued in the News Release [1/2020](#) of 6 January 2020, the monthly percentage change for November 2019 has been revised from +0.2% to 0.1% in the euro area. The annual percentage change remains unchanged at -1.4% in the euro area.
