
## Volume of retail trade down by 1.6% in euro area

Down by 1.3% in EU27

In December 2019 compared with November 2019, the seasonally adjusted volume of retail trade decreased by 1.6% in the **euro area** (EA19) and by 1.3% in the **EU27**, according to estimates from **Eurostat, the statistical office of the European Union**. In November 2019, the retail trade volume increased by 0.8% in the **euro area** and by 0.9% in the **EU27**.

In December 2019 compared with December 2018, the calendar adjusted retail sales index increased by 1.3% in the **euro area** and by 1.9% in the **EU27**.

The average retail trade for the year 2019, compared with 2018, rose by 2.2% in the **euro area** and by 2.4% in **EU27**.



## Monthly comparison by retail sector and by Member State

In the **euro area** in December 2019, compared with November 2019, the volume of retail trade decreased by 1.6% for non-food products and by 1.4% for food, drinks and tobacco and automotive fuels. In the **EU27**, the volume of retail trade decreased by 1.6% for non-food products, by 1.3% for food, drinks and tobacco and by 0.9% for automotive fuels.

Among Member States for which data are available, the largest decreases in the total retail trade volume were registered in **Germany** (-3.3%), **Slovenia** (-2.8%) and **Finland** (-2.3%). The highest increases were observed in **Ireland** (+2.7%), **Malta** (+1.3%) and **Romania** (+0.8%).

## Annual comparison by retail sector and by Member State

In the **euro area** in December 2019, compared with December 2018, the volume of retail trade increased by 3.6% for non-food products while food, drinks and tobacco decreased by 0.7% and automotive fuel by 3.7%. In the **EU27**, the retail trade volume increased by 4.0% for non-food products while food, drinks and tobacco decreased by 0.3% and automotive fuel by 2.6%.

Among Member States for which data are available, the highest yearly increases in the total retail trade volume were registered in **Romania** (+8.5%), **Hungary** (+6.1%) and **Malta** (+5.6%). The largest decreases were observed in **Slovenia** (-6.6%), **Slovakia** (-2.5%), and **Finland** (-1.6%).

## Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU27) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

## Methods and definitions

The **index of the volume of retail trade** measures the evolution of the turnover in retail trade, adjusted for price changes (deflated), i.e. the evolution of the total amount of goods sold, based on data adjusted for calendar and seasonal effects.

**Seasonally adjusted** euro area and EU series are calculated by aggregating the seasonally adjusted national data. Eurostat carries out the seasonal adjustment of the data for those countries that do not adjust their data for seasonal effects.

Missing observations from Member States for recent months are estimated for the calculation of the euro area and the EU aggregates.

## Revisions and timetable

Data of previous months have been revised compared to those issued in the News Release [3/2020](#) of 7 January 2020. The monthly percentage change for November 2019 has been revised from +1.0% to +0.8% in the euro area. The annual percentage change was revised from +2.2% to +2.3% in the euro area.
