

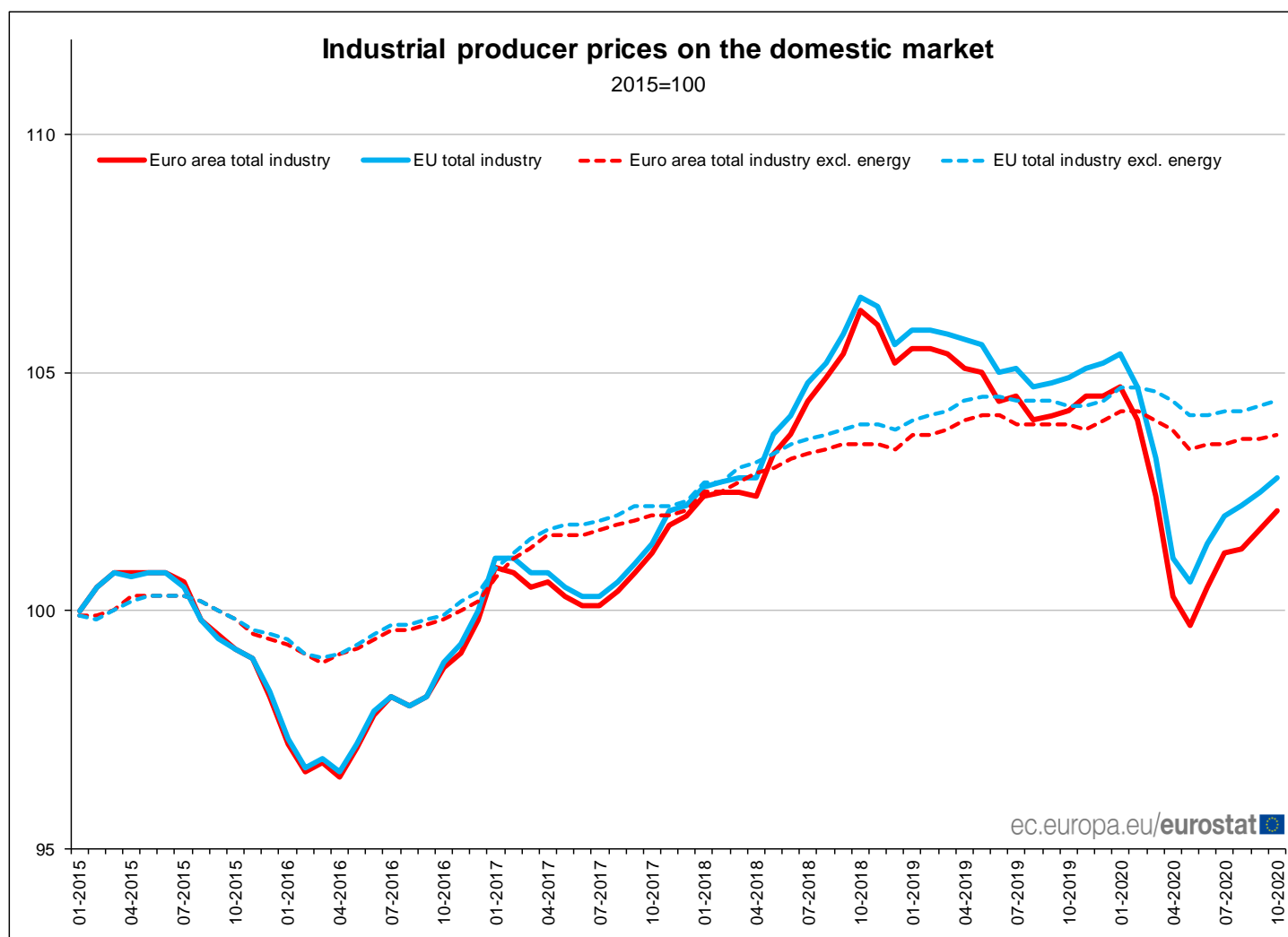

October 2020 compared with September 2020

Industrial producer prices up by 0.4% in the euro area and by 0.3% in the EU

In October 2020, industrial producer prices rose by 0.4% in the **euro area** and by 0.3% in the **EU**, compared with September 2020, according to estimates from **Eurostat, the statistical office of the European Union**. In September 2020, prices increased by 0.4% in the **euro area** and by 0.3% in the **EU**.

In October 2020, compared with October 2019, industrial producer prices decreased by 2.0% in both the **euro area** and the **EU**.



Monthly comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in October 2020, compared with September 2020, increased by 1.4% in the energy sector and by 0.1% for intermediate goods, capital goods and non-durable consumer goods, while prices remained stable for durable consumer goods. Prices in total industry excluding energy increased by 0.1%.

In the **EU**, industrial producer prices increased by 0.8% in the energy sector, by 0.2% for intermediate goods and by 0.1% for capital goods and non-durable consumer goods, while prices remained stable for durable consumer goods. Prices in total industry excluding energy increased by 0.1%.

The highest increases in industrial producer prices were recorded in **Belgium** (+3.7%), **Ireland** (+2.1%) and **Croatia** (+1.1%), while the largest decreases were observed in **Denmark** (-2.4%), **Cyprus** (-0.5%), **Spain** and **Latvia** (both -0.4%).

Annual comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in October 2020, compared with October 2019, decreased by 7.6% in the energy sector and by 1.3% for intermediate goods, while prices rose by 0.1% for non-durable consumer goods, by 0.8% for capital goods and by 1.2% for durable consumer goods. Prices in total industry excluding energy decreased by 0.2%.

In the **EU**, industrial producer prices decreased by 7.7% in the energy sector and by 1.1% for intermediate goods, while prices rose by 0.4% for non-durable consumer goods, by 1.0% for capital goods and by 1.3% for durable consumer goods. Prices in total industry excluding energy increased by 0.1%.

The largest decreases in industrial producer prices were observed in **Cyprus** (-8.0%), **Lithuania** (-6.9%) and **Denmark** (-4.8%), while the highest increases were recorded in **Ireland** (+2.8%), **Malta** (+1.7%), **Hungary** (+1.2%).

Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU27) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

Methods and definitions

The **index of producer prices** shows (in the national currency of the country concerned) changes in the ex-works sale prices of all products sold on the domestic market, excluding imports. Euro area and EU indices refer to overall weighted price changes. The figures are not calendar day or seasonally adjusted.

Total industry covers NACE rev.2 sections B to D + E36.

Revisions and timetable

Compared with data issued in the News Release 164/2020 of 4 November 2020, the monthly percentage change for September 2020 has been revised from +0.3% to +0.4% in the euro area and remains unchanged at +0.3% in the EU. The annual percentage change has been revised from -2.4% to -2.3% in the euro area and from -2.4% to -2.2% in the EU.
