
June 2020 compared with May 2020

Volume of retail trade up by 5.7% in euro area

Up by 5.2% in EU

In June 2020, a month marked by some relaxation of COVID-19 containment measures in many Member States, the seasonally adjusted volume of retail trade increased by 5.7% in the **euro area** and by 5.2% in the **EU**, compared with May 2020, according to estimates from **Eurostat, the statistical office of the European Union**. In May 2020, the retail trade volume increased by 20.3% in the **euro area** and by 18.3% in the **EU**. This means that retail trade volumes in both zones have returned to the levels recorded in February 2020, before the start of containment measures.

In June 2020 compared with June 2019, the calendar adjusted retail sales index increased by 1.3% in both the **euro area** and **EU**.



Monthly comparison by retail sector and by Member State

In the **euro area** in June 2020, compared with May 2020, the volume of retail trade increased by 20.4% for automotive fuels and by 12.1% for non-food products while food, drinks and tobacco decreased by 2.7%. In the **EU**, the volume of retail trade increased by 16.9% for automotive fuels and by 10.6% for non-food products while food, drinks and tobacco decreased by 2.2%.

Among Member States for which data are available, the highest increases in the total retail trade volume were registered in **Ireland** (+21.9%), **Spain** (+16.5%) and **Italy** (+13.8%). Decreases were observed in **Austria** (-2.5%) and **Germany** (-1.6%).

Annual comparison by retail sector and by Member State

In the **euro area** in June 2020, compared with June 2019, the volume of retail trade increased by 3.9% for non-food products and by 1.2% for food, drinks and tobacco while automotive fuel decreased by 13.6%. In the **EU**, the retail trade volume increased by 4.2% for non-food products and by 0.7% for food, drinks and tobacco while automotive fuel decreased by 12.7%.

Among Member States for which data are available, the highest yearly increases in the total retail trade volume were registered in **Ireland** (+10.2%), **Estonia** (+6.6%) and **Denmark** (+6.5%). The largest decreases were observed in **Bulgaria** (-18.1%), **Malta** (-8.4%) and **Luxembourg** (-7.7%).

Geographical information

The **euro area (EA19)** includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union (EU27)** includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

Methods and definitions

The **index of the volume of retail trade** measures the evolution of the turnover in retail trade, adjusted for price changes (deflated), i.e. the evolution of the total amount of goods sold, based on data adjusted for calendar and seasonal effects.

Seasonally adjusted euro area and EU series are calculated by aggregating the seasonally adjusted national data. Eurostat carries out the seasonal adjustment of the data for those countries that do not adjust their data for seasonal effects.

Missing observations from Member States for recent months are estimated for the calculation of the euro area and the EU aggregates.

Revisions and timetable

Data of previous months have been revised compared to those issued in the News Release [108/2020](#) of 6 July 2020. The monthly percentage change for May 2020 has been revised from +17.8% to +20.3% in the euro area and from +16.4% to +18.3% in the EU. The annual percentage change was revised from -5.1% to -3.1% in the euro area and from -4.2% to -2.6% in the EU.
