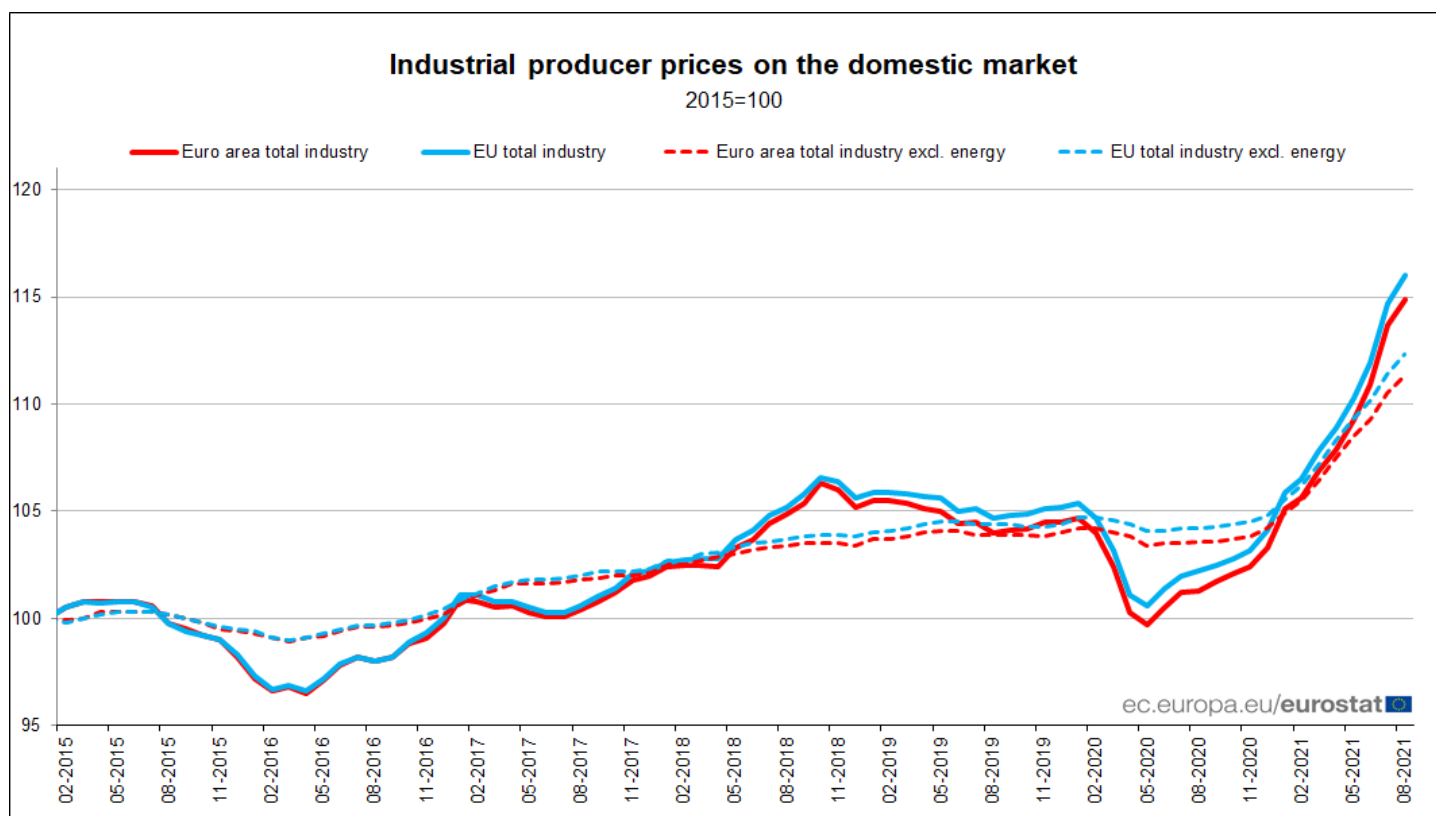
August 2021 compared with July 2021

Industrial producer prices up by 1.1% in both the euro area and the EU

Up by 13.4% in the euro area and by 13.5% in the EU compared with August 2020

In August 2021, industrial producer prices rose by 1.1% in both the **euro area** and the **EU**, compared with July 2021, according to estimates from **Eurostat, the statistical office of the European Union**. In July 2021, prices increased by 2.5% in both the **euro area** and the **EU**.

In August 2021, compared with August 2020, industrial producer prices increased by 13.4% in the **euro area** and by 13.5% in the **EU**.



Monthly comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in August 2021, compared with July 2021, increased by 2.0% in the energy sector, by 1.4% for intermediate goods, by 0.5% for capital goods, by 0.3% for durable consumer goods and by 0.2% for non-durable consumer goods. Prices in total industry excluding energy increased by 0.7%.

In the **EU**, industrial producer prices increased by 2.1% in the energy sector, by 1.4% for intermediate goods, by 0.5% for capital goods and for durable consumer goods and by 0.3% for non-durable consumer goods. Prices in total industry excluding energy increased by 0.8%.

The highest monthly increases in industrial producer prices were recorded in **Bulgaria** (+4.2%), **Denmark** (+3.1%) and **Latvia** (+2.6%), while decreases were observed only in **Ireland** (-4.1%) and **Malta** (-0.1%).

Annual comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in August 2021, compared with August 2020, increased by 32.0% in the energy sector, by 14.2% for intermediate goods, by 3.1% for capital goods, by 3.0% for durable consumer goods and by 2.8% for non-durable consumer goods. Prices in total industry excluding energy increased by 7.4%.

In the **EU**, industrial producer prices increased by 31.2% in the energy sector, by 14.7% for intermediate goods, by 3.5% for durable consumer goods, by 3.1% for capital goods and by 3.0% for non-durable consumer goods. Prices in total industry excluding energy increased by 7.8%.

The industrial producer prices increased in all Member States, with the highest yearly increases being registered in **Ireland** (+54.8%), **Belgium** (+23.9%) and **Denmark** (+23.8%).

Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU27) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

Methods and definitions

The **index of producer prices** shows (in the national currency of the country concerned) changes in the ex-works sale prices of all products sold on the domestic market, excluding imports. Euro area and EU indices refer to overall weighted price changes. The figures are not calendar day or seasonally adjusted.

Total industry covers [NACE rev.2](#) sections B to D + E36.

Revisions and timetable

Compared with data issued in the News Release [99/2021](#) of 2 September 2021, the monthly percentage change for July 2021 has been revised from +2.3% to +2.5% in the euro area and from +2.2% to +2.5% in the EU. The annual percentage change has been revised from +12.1% to +12.4% in the euro area and from +12.2% to +12.5% in the EU.
