
January 2022 compared with December 2021

Volume of retail trade up by 0.2% in euro area and by 0.6% in the EU

Up by 7.8% and 8.3% compared with January 2021

In January 2022, the seasonally adjusted volume of retail trade increased by 0.2% in the **euro area** and by 0.6% in the **EU**, compared with December 2021, according to estimates from **Eurostat, the statistical office of the European Union**. In December 2021, the retail trade volume fell by 2.7% in the **euro area** and by 2.6% in the **EU**.

In January 2022 compared with January 2021, the calendar adjusted retail sales index increased by 7.8% in the **euro area** and by 8.3% in the **EU**.



Monthly comparison by retail sector and by Member State

In the **euro area** in January 2022, compared with December 2021, the volume of retail trade increased by 0.2% for non-food products, remained unchanged for food, drinks and tobacco, and fell by 1.3% for automotive fuels.

In the **EU**, the volume of retail trade increased by 1.0% for non-food products and by 0.2% for food, drinks and tobacco, while it fell by 1.1% for automotive fuels.

Among Member States for which data are available, the highest monthly increases in the total retail trade volume were registered in **Poland** (+5.9%), **Luxembourg** (+4.2%) and **Denmark** (+3.7%). The largest decreases were observed in **Slovenia** (-4.6%), **Portugal** (-2.8%), and **Lithuania** (-2.5%).

Annual comparison by retail sector and by Member State

In the **euro area** in January 2022, compared with January 2021, the volume of retail trade increased by 14.8% for non-food products and by 12.7% for automotive fuels, while it fell by 1.7% for food, drinks and tobacco.

In the **EU**, the retail trade volume increased by 15.3% for non-food products, and by 11.1% for automotive fuels, while it fell by 1.3% for food, drinks and tobacco.

Among Member States for which data are available, the highest yearly increases in the total retail trade volume were registered in **Slovenia** (+32.3%), **Poland** (+19.5%) and **Lithuania** (+18.2%). The only decrease was observed in **Finland** (-2.4%).

Geographical information

The **euro area (EA19)** includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union (EU27)** includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

Methods and definitions

The **index of the volume of retail trade** measures the evolution of the turnover in retail trade, adjusted for price changes (deflated), i.e. the evolution of the total amount of goods sold, based on data adjusted for calendar and seasonal effects.

Seasonally adjusted euro area and EU series are calculated by aggregating the seasonally adjusted national data. Eurostat carries out the seasonal adjustment of the data for those countries that do not adjust their data for seasonal effects.

Missing observations from Member States for recent months are estimated for the calculation of the euro area and the EU aggregates.

Revisions and timetable

Data of previous months have been revised compared to those issued in the News Release [19/2022](#) of 4 February 2022. The monthly percentage change for December 2021 has been revised from -3.0% to -2.7% in the euro area and from -2.8% to -2.6% in the EU. The annual percentage change has been revised from +2.0% to +2.1% in the euro area and from +2.6% to +2.9% in the EU.
