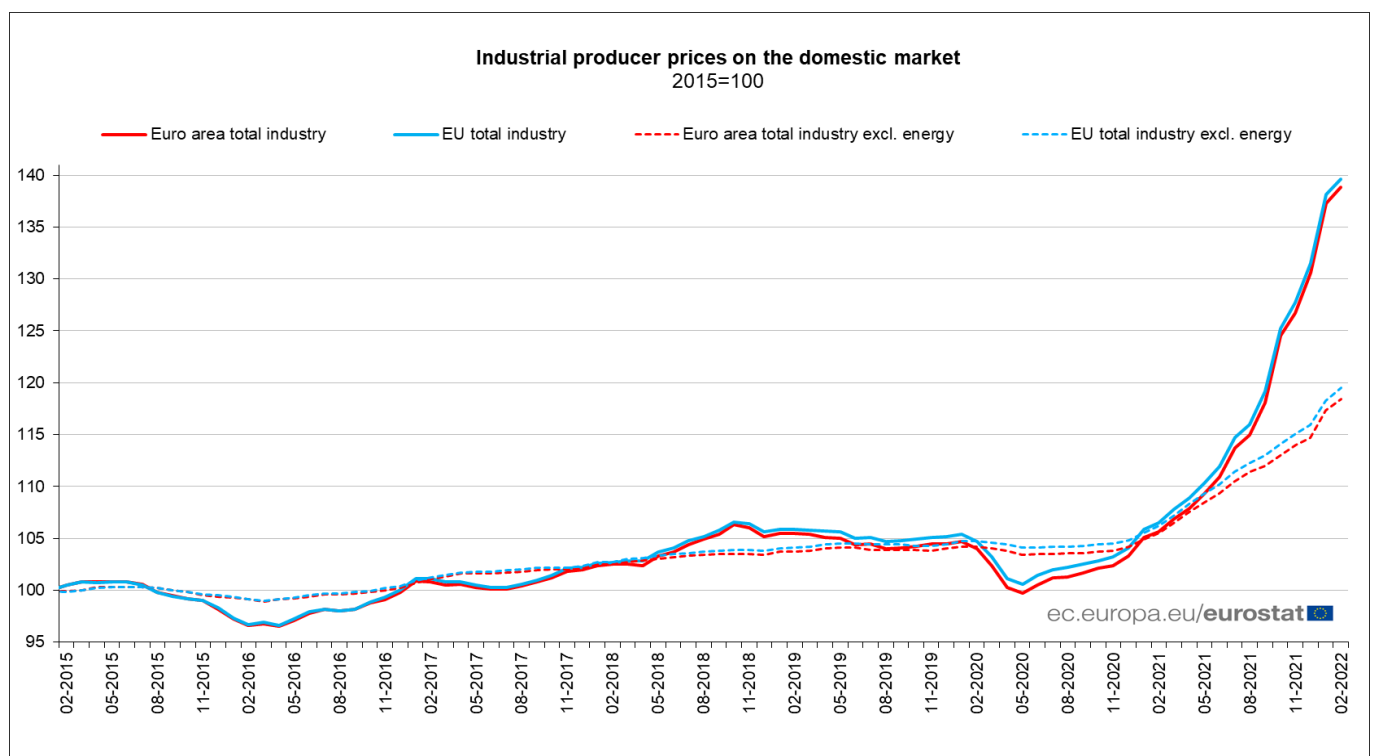
February 2022 compared with January 2022

Industrial producer prices up by 1.1% in both the euro area and the EU

Up by 31.4% in the euro area and by 31.1% in the EU compared with February 2021

In February 2022, industrial producer prices rose by 1.1% in both the **euro area** and the **EU**, compared with January 2022, according to estimates from **Eurostat, the statistical office of the European Union**. In January 2022, prices increased by 5.1% in the **euro area** and by 5.0% in the **EU**.

In February 2022, compared with February 2021, industrial producer prices increased by 31.4% in the **euro area** and by 31.1% in the **EU**.



Monthly comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in February 2022, compared with January 2022, increased by 1.6% for intermediate goods, by 1.3% in the energy sector, by 0.8% for non-durable consumer goods, by 0.6% for durable consumer goods and by 0.3% for capital goods. Prices in total industry excluding energy increased by 0.9%.

In the **EU**, industrial producer prices increased by 1.5% for intermediate goods, by 1.4% in the energy sector, by 1.0% for non-durable consumer goods, by 0.7% for durable consumer goods and by 0.4% for capital goods. Prices in total industry excluding energy increased by 1.0%.

The highest monthly increases in industrial producer prices were recorded in **Slovakia** (+13.6%), **Slovenia** (+5.7%) and **Greece** (+4.8%). Decreases were observed in **Ireland** (-8.1%), **Finland** (-0.5%), **Latvia** (-0.3%), and **Bulgaria** (-0.1%).

Annual comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in February 2022, compared with February 2021, increased by 87.2% in the energy sector, by 20.8% for intermediate goods, by 7.2% for durable consumer goods, by 6.8% for non-durable consumer goods and by 5.9% for capital goods. Prices in total industry excluding energy increased by 12.2%.

In the **EU**, industrial producer prices increased by 83.6% in the energy sector, by 21.1% for intermediate goods, by 7.7% for durable consumer goods, by 7.4% for non-durable consumer goods and by 6.0% for capital goods. Prices in total industry excluding energy increased by 12.5%.

The industrial producer prices increased in all Member States, with the highest yearly increases being registered in **Ireland** (+63.4%), **Romania** (+57.7%) and **Denmark** (+53.8%).

Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU27) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

Methods and definitions

The **index of producer prices** shows (in the national currency of the country concerned) changes in the ex-works sale prices of all products sold on the domestic market, excluding imports. Euro area and EU indices refer to overall weighted price changes. The figures are not calendar day or seasonally adjusted.

Total industry covers NACE rev.2 sections B to D + E36.

Revisions and timetable

Compared with data issued in the News Release 26/2022 of 3 March 2022, the monthly percentage increases for January 2022 changed from +5.2% to +5.1% in the euro area and from +4.9% to +5.0% in the EU. The annual percentage increases remains unchanged at +30.6% in the euro area and changed from +30.3% to +30.4% in the EU.
