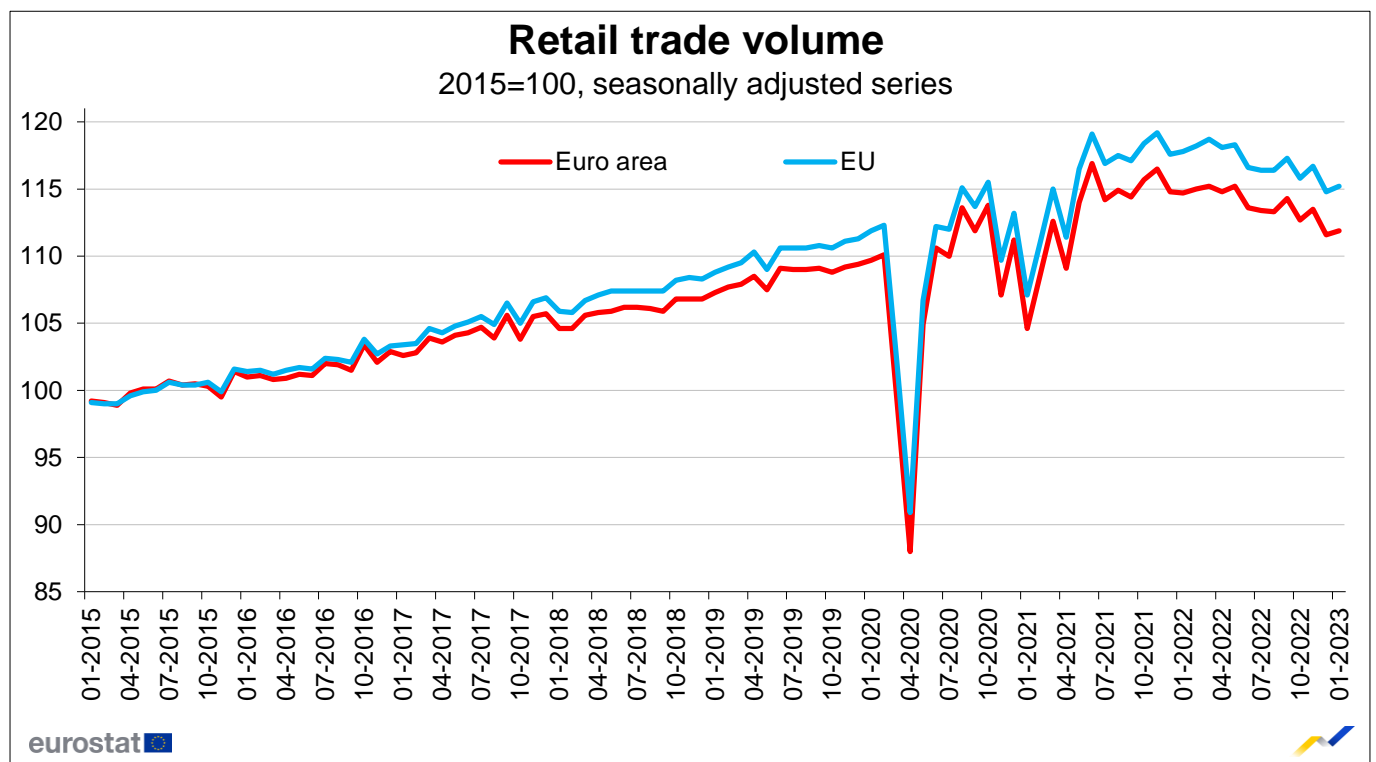
January 2023 compared with December 2022

## Volume of retail trade up by 0.3% in both the euro area and the EU

Down by 2.3% in the euro area and by 2.2% in the EU compared with January 2022

In January 2023, the seasonally adjusted volume of retail trade increased by 0.3% in both the **euro area** and the **EU**, compared with December 2022, according to estimates from **Eurostat, the statistical office of the European Union**. In December 2022, the retail trade volume decreased by 1.7% in the **euro area** and by 1.6% in the **EU**.

In January 2023 compared with January 2022, the calendar adjusted retail sales index decreased by 2.3% in the **euro area** and by 2.2% in the **EU**.



### Monthly comparison by retail sector and by Member State

In the **euro area** in January 2023, compared with December 2022, the volume of retail trade increased by 1.8% for food, drinks and tobacco and by 0.8% for non-food products, while it decreased by 1.5% for automotive fuels.

In the **EU**, the volume of retail trade increased by 1.8% for food, drinks and tobacco and by 1.1% for non-food products, while it decreased by 2.1% for automotive fuels.

Among Member States for which data are available, the highest monthly increases in the total retail trade volume were registered in the **Netherlands** (+4.9%), **Luxembourg** (+4.6%) and **Slovenia** (+4.1%). The largest decreases were observed in **Austria** (-9.8%), **Slovakia** (-1.4%) and **Hungary** (-0.6%).

## Annual comparison by retail sector and by Member State

In the **euro area** in January 2023, compared with January 2022, the volume of retail trade decreased by 5.0% for food, drinks and tobacco and by 1.0% for non-food products, while it grew by 5.4% for automotive fuels.

In the **EU**, the retail trade volume decreased by 4.7% for food, drinks and tobacco and by 1.0% for non-food products, while it grew by 5.6% for automotive fuels.

Among Member States for which data are available, the largest yearly decreases in the total retail trade volume were registered in **Belgium** (-8.9%), **Germany** (-6.8%), **Denmark** and **Sweden** (both -5.8%). The highest increases were observed in **Slovenia** (+18.5%), **Romania** (+5.8%) and **Malta** (+5.7%).

## Geographical information

Up to 31 December 2022, the **euro area** (EA19) included Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland. From 1 January 2023 the **euro area** (EA20) also includes Croatia.

The aggregate data series commented on in this News Release refer to the official composition of the euro area in the most recent month for which data is available. Thus, News Releases with data for months up to December 2022 commented on EA19 series, while Releases with data for January 2023 onwards comment on EA20 series.

The **European Union** (EU27) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

## Methods and definitions

The **index of the volume of retail trade** measures the evolution of the turnover in retail trade, adjusted for price changes (deflated), i.e. the evolution of the total amount of goods sold, based on data adjusted for calendar and seasonal effects.

**Seasonally adjusted** euro area and EU series are calculated by aggregating the seasonally adjusted national data. Eurostat carries out the seasonal adjustment of the data for those countries that do not adjust their data for seasonal effects.

Missing observations from Member States for recent months are estimated for the calculation of the euro area and the EU aggregates.

## Revisions and timetable

Data of previous months have been revised compared to those issued in the News Release [19/2023](#) of 6 February 2023. The monthly percentage change for December 2022 has been revised from -2.7% to -1.6% in the euro area (EA19) and from -2.6% to -1.6% in the EU. The annual percentage change remained unchanged at -2.8% in the euro area (EA19) and at -2.5% in the EU.
