

September 2015 **Annual inflation down to -0.1% in the euro area** Down to -0.1% in the EU

Euro area annual inflation was -0.1% in September 2015, down from 0.1% in August. In September 2014 the rate was 0.3%. **European Union** annual inflation was -0.1% in September 2015, down from 0.0% in August. A year earlier the rate was 0.4%. These figures come from **Eurostat**, **the statistical office of the European Union**.

In September 2015, negative annual rates were observed in seventeen Member States. The lowest annual rates were registered in **Cyprus** (-1.9%), **Romania** (-1.5%) and **Spain** (-1.1%). The highest annual rates were recorded in **Malta** (1.6%), **Belgium**, **Portugal** and **Sweden** (all 0.9%). Compared with August 2015, annual inflation fell in eighteen Member States, remained stable in four and rose in six.

The largest upward impacts to **euro area** annual inflation came from restaurants & cafés (+0.12 percentage points), vegetables (+0.11 pp) and tobacco (+0.08 pp), while fuels for transport (-0.71 pp), heating oil (-0.25 pp) and milk, cheese & eggs (-0.06 pp) had the biggest downward impacts.




Annual inflation rates (%) in September 2015, in ascending order

Geographical coverage

The **euro area** consists of Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** includes Belgium, Bulgaria, the Czech Republic, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland, Sweden and the United Kingdom.

The euro area and European Union data refer to the respective country compositions at a specific point in time. New Member States are integrated into the aggregates using a chain index formula.

Methods and definitions

The **annual rate** measures the change of the Harmonised Indices of Consumer Prices (HICP) between a month and the same month of the previous year, and the **monthly rate** compares the indices between the two latest months.

An **impact** is a measure showing the change in the inflation due to the inclusion of a sub-index. The impact takes account of both the weight and whether the inflation for that sub-index is higher or lower than the all-items inflation rate.

Revisions and timetable

A flash estimate of euro area inflation is issued at the end of each reference month. The euro area <u>flash estimate for September</u> <u>2015</u>, published on 30 September 2015, was -0.1%.

The next flash estimate of euro area inflation with data for October 2015 is scheduled for 30 October 2015.

Figures for the reference month are provisional and can be revised in the following month.
