
December 2018 compared with November 2018

Industrial producer prices down by 0.8% in both euro area and EU28

In December 2018, compared with November 2018, industrial producer prices fell by 0.8% in both the **euro area** (EA19) and the **EU28**, according to estimates from **Eurostat, the statistical office of the European Union**. In November 2018, prices decreased by 0.3% in the **euro area** and by 0.5% in the **EU28**.

In December 2018, compared with December 2017, industrial producer prices rose by 3.0% in the **euro area** and by 3.1% in the **EU28**.

Average industrial producer prices for the year 2018, compared with 2017, increased by 3.2% in the **euro area** and by 3.6% in the **EU28**.



Monthly comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in December 2018, compared with November 2018, fell by 2.6% in the energy sector and by 0.4% for intermediate goods, while prices remained stable for non-durable consumer goods and increased by 0.1% for capital goods and by 0.2% for durable consumer goods. Prices in total industry excluding energy fell by 0.1%.

In the **EU28**, industrial producer prices fell by 3.3% in the energy sector and by 0.3% for intermediate goods, while prices remained stable for capital goods and rose by 0.1% for both durable and non-durable consumer goods. Prices in total industry excluding energy fell by 0.1%.

The largest decreases in industrial producer prices were recorded in **Denmark** (-3.0%), **Greece** (-2.3%), **Belgium** (-2.1%) and the **Netherlands** (-1.5%), while increases were observed in **Latvia** (+0.7%), **Ireland** (+0.3%), **Estonia** (+0.2%) and **Luxembourg** (+0.1%).

Annual comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in December 2018, compared with December 2017, rose by 7.7% in the energy sector, by 2.2% for intermediate goods, by 1.3% for durable consumer goods, by 1.2% for capital goods and by 0.2% for non-durable consumer goods. Prices in total industry excluding energy rose by 1.3%.

In the **EU28**, industrial producer prices rose by 7.5% in the energy sector, by 2.6% for intermediate goods, by 1.5% for durable consumer goods, by 1.3% for capital goods and by 0.4% for non-durable consumer goods. Prices in total industry excluding energy rose by 1.5%.

The highest increases in industrial producer prices were recorded in **Estonia** (+9.2%), **Latvia** (+7.3%), **Belgium** and **Denmark** (both +7.1%), while the only decreases were observed in **Ireland** (-0.4%) and **Greece** (-0.1%)

Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU28) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland, Sweden and the United Kingdom.

Methods and definitions

The **index of producer prices** shows (in the national currency of the country concerned) changes in the ex-works sale prices of all products sold on the domestic market, excluding imports. Euro area and EU indices refer to overall weighted price changes. The figures are not calendar day or seasonally adjusted.

Total industry covers NACE rev.2 sections B to D + E36.

Revisions and timetable

Compared with data issued in the News Release 2/2019 of 4 January 2019, the monthly percentage change for November 2018 remains unchanged at -0.3% in the euro area and has been revised from -0.4% to -0.5% in the EU28. The annual percentage change remains unchanged at +4.0% in the euro area and has been revised from +4.3% to +4.2% in the EU28.
